A. L. A. NEWS

West Baden, Indiana, was selected by the Executive Board for the next annual conference, provided the President and Secretary can make satisfactory arrangements with the hotels. The dates tentatively approved are May 28 to June 2.

A plan for the continuation of the Paris Library School, under auspices other than the A. L. A. after the five-year demonstration period, was approved by the Board. The plan had been drawn up by the director and faculty and was presented with the approval of the President of the Association and a group of nine men and women who had been invited by him to consider the plan. (Details will be published as soon as space permits.)

An invitation from the officers and program committee of the Southwestern Library Association to the Executive

Board, Board of Education for Librarianship, Board on the Library and Adult Education, and Library Extension Committee was considered by the Executive Board and it was voted to recommend to these boards and committees that, if consistent with their plans, they arrange to hold meetings in connection with the meeting of the Southwestern Library Association in Baton Rouge, April 12-14.

The Board also voted that, if the President finds it necessary to call a meeting of the Executive Board in April, such meeting be held in connection with the Southwestern Library Association meeting. (These motions were passed before the time and place of the next A. L. A. Conference had been agreed upon. The suggested early date for the A. L. A. meeting will necessarily affect the situation.)
