The Common Council met in regular session.

Present—His Honor, the Mayor, John Caven, in the chair, and the following members :

The proceedings of the regular session, held October 25th, 1875, were read and approved.

Sealed proposals for grading and graveling the first alley north of Deloss street, between Dillon and Leota streets.

Also, for grading and graveling the first alley east of Charles street, from St. Clair to John street ; and also the first alley north of St. Clair street, from Charles street to the first described alley.

Also, for grading and graveling the first alley west of Plum street, between Vine street and Cherry street.

Also, for grading and graveling the alley between Waters and Greer streets, and running from McCarty street to the first alley south of Stevens street.

Also, for grading and graveling Arsenal avenue and west sidewalk, and paving the east sidewalk thereof, from Washington street to the track of the Pittsburgh, Cincinnati & St. Louis Railroad.

Were received, opened, read and referred to the Committee on Contracts.

Mr. Kahn, from the Committee on Contracts, submitted the following report :

INDIANAPOLIS, November 1, 1875.

To the Mayor and Common Council of the City of Indianapolis :

Gentlemen. :—Your Committee on Contracts, to whom was referred sundry proposals, report that we have examined the same and find them to be as follows, to-wit :

FIRST.

For grading and graveling with good pit gravel the first alley east of Yandes street, between Malotte avenue and Lincoln avenue, the following proposals were presented, viz :

M. M. Hook, 44 cents per foot front each side where 25 feet wide ; 34 cents per foot front each side where 15 feet wide.

Samuel C. Hanna, 40 cents per foot front each side where 25 feet wide : 27 cents per foot front each side where 15 feet wide.

James Garner, 39 cents per foot front each side where 25 feet wide ; 30 cents per foot front each side where 15 feet wide.

Samuel P. Strong, 38 cents per foot front each side where 25 feet wide ; 28 cents per foot front each side where 15 feet wide.

Henry Clay being the lowest and best bidder, we recommend that he be awarded the contract.

For grading and graveling with good pit gravel the first alley south of Christian avenue, from Peru to Oak street, the following proposals were presented, viz :

Samuel C. Hanna, 26 cents per foot front each side.

M. M. Hook, 24½ cents per foot front each side.

Wm. Morrison, 23 cents per foot front each side.

Henry Clay, 21 cents per front foot each side.

Henry Clay being the lowest and best bidder, we recommend that he be awarded the contract.

THIRD.

For grading and graveling the alley running southeast and northwest between Huron and Ellen streets, from Grove to Dillon, the following proposals were presented, viz :

James Mahoney, 16 cents per front foot each side.

Frank Eppert, 15½ cents per front foot each side.

Wm. Sonnefield, 15 cents per foot front each side.

William Sonnefield being the lowest and best bidder, we recommend that he be awarded the contract.

FOURTH.

For grading and graveling Olive street and sidewalks, from Prospect street to Lexington avenue, the following proposals were presented, viz :

Sol. Devenish, 89 cents per front foot on each side.

Wm. Sonnefield, 77 cents per front foot on each side.

John Greene, 71 cents per front foot on each side.

Mann & Buchanan, 68 cents per front foot on each side.

James Mahoney, 68 cents per front foot on each side.

Fred Gansberg, 63 cents per front foot on each side.

Fred Gansberg being the lowest and best bidder, we recommend that he be awarded the contract.

FIFTH.

For grading, graveling, paving and curbing the first alley east of East street, running from North to Michigan street, the following proposals were presented, viz :

Sol. Devenish, \$1.27 per lineal foot front on each side.

James Mahoney, grading and graveling, 37 cents per front foot on each side ; paving, 35 cents per front foot on each side ; curbing, 50 cents per front foot on each side.

H. C. Roney, grading and graveling, 30 cents per front foot on each side ; paving, 35 cents per front foot on each side ; curbing, 48 cents per front foot on each side.

Henry C. Roney being the lowest and best bidder, we recommend that he be awarded the contract.

Sol Devenish, 80 cents per lineal foot for paving; 80 cents per lineal foot for bouldering; 45 cents per lineal foot for flagging.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen.—Hill avenue and Baltimore avenue cannot at present be improved, as I cannot obtain drainage or secure an outlet for the water on said street.

The only drainage I can obtain for these streets would be over private property. and until the State Ditch is deepened or some provisions made for draining that portion of the country, the grade for said streets cannot be established.

The best plan to secure said drainage will be to deepen the State Ditch five feet from Hill avenue to Fall Creek, and which I recommended in my former report.

SECOND.

Sanders street can not be improved under the present ordinance, as there is no out-let for the water on the west side of said street except over private property.

A portion of said street can be improved on the east end, by first laying down eight hundred feet of twenty-four inch sewer pipe to convey the water to the Shelby street sewer, and filling up the large ponds now existing in said street.

After this is done an ordinance can be introduced for the improving of the east end of said street and running west for seven hundred feet.

THIRD.

In compliance with your orders I have located 42 new lamps on the following streets to-wit :

On Third street between Tennessee street and the Central Canal.....	11
On Fourth street between Illinois street and Central Canal.....	14
