Proceedings of Joint Convention.

THIRD SESSION—Monday, November 10, 1890.

The Common Council and Board of Aldermen of the City of Indianapolis convened in Joint Convention in the Council Chamber, Monday evening, November 10th, 1890, at eight o'clock, in compliance with the provisions of Section four of the following entitled Act of the General Assembly of the State of Indiana, approved March 8th, 1881:

An Act supplemental to an Act approved March 14th, 1867, entitled "An Act to repeal all general laws now in force for the incorporation of cities, and to provide for the incorporation of cities; prescribing their powers and rights, and the manner in which they shall exercise the same, and to regulate such other matters as pertain thereto."

Mayor Sullivan, President of the Joint Convention, in the Chair, directed the Secretary to call the roll.

The roll of the members of the Board of Aldermen and Common Council having been called, the following members of the Joint Convention were found to be present:

Aldermen Blackweil, Breunig, Farrell, Laut, Reilly, Reinecke, Reynolds, Smith, Smither, and President Thalman—10; Councilmen Austin, Burns, Cooper, Coy, Davis, Dunn, Gasper, Gauss, Hicklin, Markey, Martindale, Murphy, Myers, McGill, Nolan, Olsen, Pearson, Rassmann, Sherer, Stechhan, Sweetland, Trusler, Weber, Woollen, and Yontz—25. Total present, 35.

There being a quorum present, the President announced that the Joint Convention was ready for the transaction of business.

Councilman Rassmann offered the following motion, which was unanimously adopted:

That the following order of business be observed in electing City Officers:

- 2d. Chief Fire Engineer;
- 3d. Street Commissioner;
- 4th. City Civil Engineer;
- 5th. East Market Master;

- 9th. City Weigh-Master;
- 10th. Board of Health;
- 11th. Janitor of Tomlinson Hall;
- 12th. Janitor of City Hall;
- 13th. City Sexton;
- 14th. Directors of the Belt Railroad.

Councilman Markey moved that the Joint Convention proceed to elect by ballot; which was adopted.

The President appointed Alderman Reynolds and Councilman Murphy to act as tellers.

For City Attorney — Councilman Coy placed in nomination Leon O. Bailey.

Councilman Gasper placed in nomination William L. Taylor.

A ballot was then had, with the following result:

Leon O. Bailey received 20 votes.

Wm. L. Taylor received 15 votes.

Leon O. Bailey having received a majority of all the votes cast, the President declared him duly elected City Attorney for the term of two years, beginning January 1st, 1891, or until his successor is elected and qualified.

For Chief Fire Engineer—Councilman Rassmann placed in nomination Joseph H. Webster.


