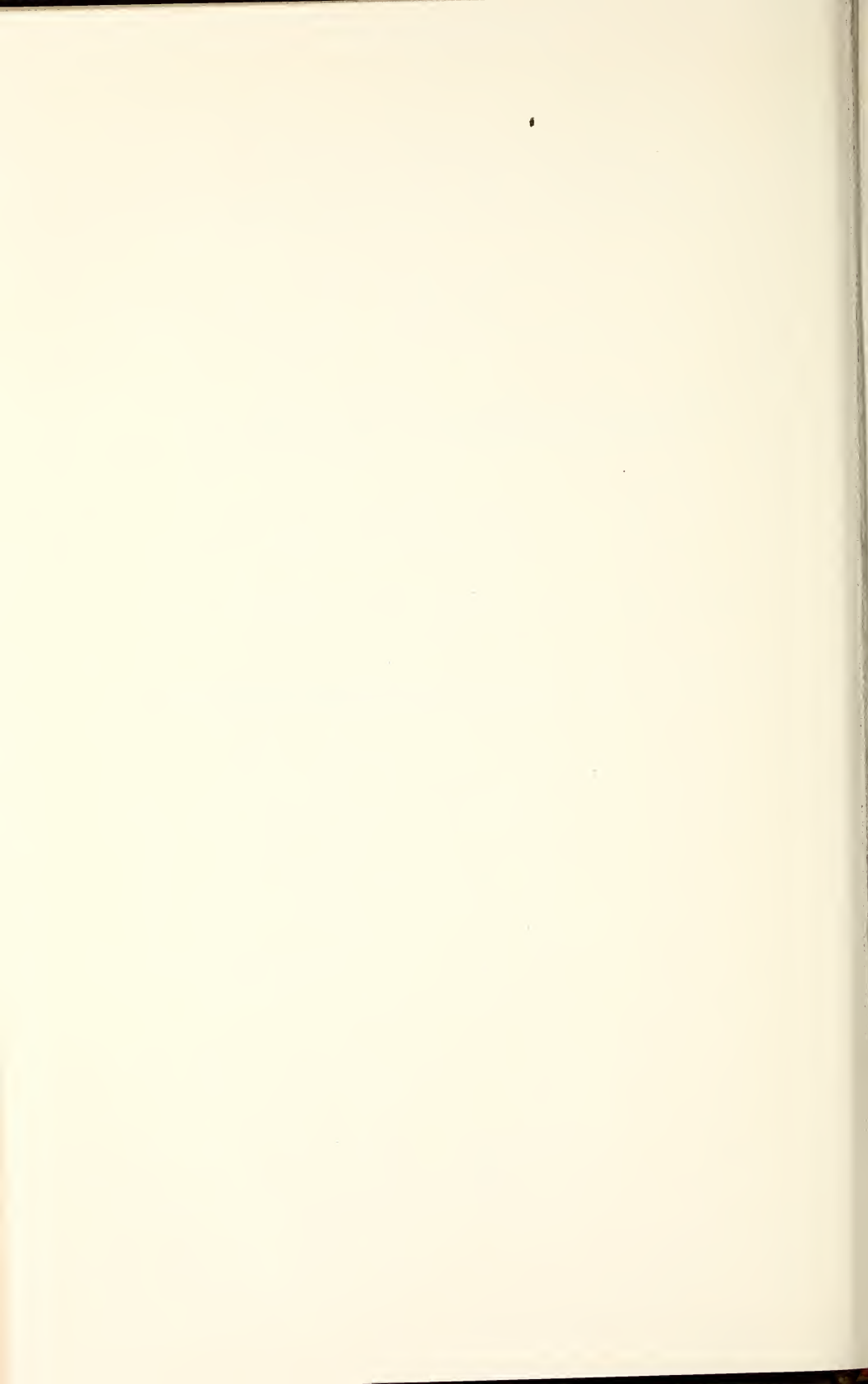

## REGULAR MEETING

Monday, January 6, 1958, 7:30 P.M.

The Common Council of the City of Indianapolis, met in the Council Chamber in the City Hall, Monday, January 6, 1958 at 7:30 P.M. in regular session.

Christian J. Emhardt in the chair.

The Clerk called the roll.

Present: Mr. Applegate, Mr. Bright, Mrs. Francis, Mr. McGill, Mr. McKinney, Mrs. Pohlmann, Mr. Williamson, Mr. Wallace, Mr. Emhardt.

Mr. Emhardt announced that the first order of business would be the election of officers for the year, 1958, and asked the City Clerk to act as temporary chairman of the meeting until the presiding officer for the year is elected.

The Chairman asked for nominations for the office of President of the Council.

Mr. Wallace nominated Mr. Christian J. Emhardt to serve as President of the Council for the year, 1958.

Mr. Bright seconded the nomination of Mr. Emhardt.

Mr. Wallace made a motion that the nominations be closed and the Deputy Clerk be instructed to cast a unanimous ballot, which was seconded by Mrs. Francis. Motion carried.

The Deputy Clerk cast the unanimous ballot.

Mr. Emhardt was elected President of the Council for the year, 1958.

On invitation of Mrs. Laffey, the Chairman, Mr. Emhardt took the chair.

President Emhardt asked for nominations for the office of Vice-President.

Mr. McGill nominated Mr. Wallace to serve as Vice-President of the Council for the year, 1958. The nomination of Mr. Wallace was seconded by Mr. McKinney.

Mr. Applegate made a motion that the nominations be closed and the Clerk be instructed to cast a unanimous ballot. Mrs. Francis seconded the motion, Motion carried.

The Clerk cast the unanimous ballot.

### INTRODUCTION OF APPROPRIATION ORDINANCES

#### APPROPRIATION ORDINANCE NO. 1, 1958

AN ORDINANCE appropriating the sum of Ninety Nine Hundred Dollars (\$9900.00) from the anticipated, unexpended and unappropriated 1958 balance of the General Fund of the City of Indianapolis, to certain designated funds and items in the Department

of Finance, City Controller, created by virtue of the 1958 Budget, General Ordinance No. 70, 1957, as Amended, for the payment of annual salaries for two (2) accounting positions in the City Controller's office, hereby creating such positions in said department, declaring an emergency and fixing a time when the same shall take effect.

WHEREAS: Certain extraordinary conditions have developed since the adoption of the existing annual budget, so that it is necessary to appropriate more money than was appropriated in the annual budget for the operation of certain functions of the Department of Finance, City Controller, and to meet such extraordinary emergencies:

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Ninety Nine Hundred Dollars (\$9900.00) from the anticipated, unexpended and unappropriated 1958 balance of the General Fund of the City of Indianapolis is hereby set apart and appropriated out of said funds as follows, to-wit:

WHEREAS: Certain extraordinary conditions have developed since the adoption of the existing annual budget, so that it is necessary to appropriate more money than was appropriated in the annual budget for the operation of certain functions of the Department of Public Safety, Dog Pound, and to meet such extraordinary emergencies:

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Twenty Eight Hundred Dollars (\$2800.00) from the anticipated, unbudgeted and unappropriated 1958 balance of the General Fund of the City of Indianapolis is hereby set apart and appropriated out of said fund as follows, to-wit:

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

## INTRODUCTION OF GENERAL ORDINANCES

By Councilman McKinney:

### GENERAL ORDINANCE NO. 1, 1958

AN ORDINANCE establishing certain passenger and/or loading zones in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owner or occupants of certain premises fronting on certain public streets in the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such



owners or occupants having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as Amended and the Board of Public Safety, after due investigation, having recommended the establishment of the same, the following passenger and/or loading zones be, and the same are, hereby established in the City of Indianapolis, to-wit:

- (a) Beginning at a point 80 ft. south of the South Curb line of East Market Street on the east side of North Pennsylvania Street, thence south a distance of 20 ft. to the South Property Line of the American Fletcher National Bank, 108 N. Pennsylvania Street, for the use and occupancy of said bank.
- (b) Beginning at a point 60 ft. south of the South Curb Line of Georgia Street and extending 60 ft. south of the east side of McCrea Street for the use and occupancy of Associated Distributors, Inc., 210 S. Meridian St.
- (c) Beginning at a point 107 ft. north of the North Curb Line of Washington Street and extending 25 ft. north on the west side of Illinois Street for the use and occupancy of the Claypool Hotel, 14 North Illinois Street.
- (d) Beginning at a point 62 ft. west of the West Curb Line of Illinois Street and extending 25 ft. west on the north side of Washington Street for the use and occupancy of the Claypool Hotel, 116 West Washington Street.
- (e) Beginning at a point 113 ft. south of the South Curb Line of Michigan Street and extending 25 ft. south on the east side of Illinois Street for the use and occupancy of P. J. Shick Company, 437 N. Illinois Street.
- (f) Beginning at a point 87 ft. south of the South Curb Line of Washington Street and extending 25 ft. south on the west side of Capitol Avenue for the use and occupancy of the Lorraine Hotel, 12 S. Capitol Avenue.
- (g) Beginning at a point 15 ft. south of the South Property Line of the first alley south of Maryland Street and extending 25 ft. south on the west side of Illinois Street for the use and occupancy of the Earle Hotel, Inc., 126 S. Illinois Street.
- (h) Beginning at a point 75 ft. east of the East Curb Line of New

Jersey Street and extending 25 ft. east on the south side of Wabash Street for the use and occupancy of Roger Popp, Inc., 111 N. New Jersey Street.

- (i) Beginning at a point 80 ft. north of the North Curb Line of the first alley south of Georgia Street and extending 25 ft. north on the West side of Illinois Street for the use and occupancy of the New Colonial Hotel, 22 S. Illinois Street.
- (j) Beginning at a point 45 ft. south of the South Curb Line of Allegheny Street and extending 25 ft. south on the west side of Meridian Street for the use and occupancy of the Continental Hotel Corp., 410 N. Meridian Street
- (k) Beginning at a point 21 ft. south of the South Curb Line of Georgia Street and extending 50 ft. south on the west side of McCrea Street for the use and occupancy of the Severin Hotel, 201 S. Illinois Street.
- (l) Beginning at a point 6 ft. south of the South Curb Line of Henry Street and extending 44 ft. south on the west side of Pennsylvania Street for the use and occupancy of McKelvey-Kell, Inc., 502 S. Pennsylvania Street.

Section 2. That said loading zones are hereby declared to be subject to all existing traffic and parking regulations and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

#### GENERAL ORDINANCE NO. 2, 1958

AN ORDINANCE to amend the Municipal Code of Indianapolis, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8, Section 4-837, sub-section 1 thereof, pertaining to prohibited parking between the hours of 2:00 A.M. and

6:00 A.M. on certain designated streets, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 8, Section 4-837, sub-section 1 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be, and the same is, hereby amended to read as follows, to-wit: Section 4-837. 1. Both sides of all streets included in the area bounded on the North by the North side of New York Street, on the East by the East side of Pennsylvania Street, on the South by the South side of Georgia Street, and on the West by the West side of Capitol Avenue; except, however, the North side of Washington Street between Capitol Avenue and Illinois Street, the West side of Illinois Street between Washington Street and Market Street, and the East side of Pennsylvania Street between Market Street and Wabash Street.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

Which was read for the first time and referred to the Committee on Public Works.

GENERAL ORDINANCE NO. 3, 1958

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8, Section 4-813 thereof, by the addition of sub-section (12) thereto, restricting parking near certain public buildings, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 8, Section 4-813 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be, and the same is, hereby amended by the addition of sub-section (12) thereto, to read as follows, to-wit:

Section 4-813 (12). No vehicles other than a vehicle used by adult parole officers, Indiana Department of Correction, shall be parked at any time on the north side of Georgia Street, beginning at a point 25 feet east of the east curb line of Meridian Street and extending east for a distance of 88 feet.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

GENERAL ORDINANCE NO. 4, 1958

AN ORDINANCE transferring the sum of \$60,000.00 from a special reserve fund of the Off Street Parking Commission to the City General Fund, and repealing Appropriation Ordinance No. 22 and General Ordinance No. 111 of 1955.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. The reserve fund now in the custody of the Off Street Parking Commission in the amount of \$60,000.00 which was created in the year 1955 to support and guarantee the payment of bond interest on the City's Off Street Parking project leased to the Grandle Company of Cincinnati, Ohio, for the erection of a City Parking Garage at Maryland and Illinois Streets on the Southwest corner thereof, is not now being used under such lease or the original plans therefor. Said project was never constructed in accordance with the plans therefor, and the Grandle Company never performed said lease and said project was never undertaken and was abandoned after an adverse decision in the Supreme Court of Indiana (Cause No. 29293), in the case of Foltz et al. versus The City of Indianapolis, but said project is proceeding under new plans and a new lessee, and there is now actual need for all of said money for the City General Fund, so that the City may carry on its necessary governmental functions, and said special fund is of no use to the Off Street Parking Commission.

Section 2. Accordingly, the said total sum of \$60,000.00 now held in the said Special Reserve Fund of the Off Street Parking Commission be, and the same is, hereby transferred and allocated to the General Fund of the City of Indianapolis.

Section 3. The City Clerk shall give the requisite notice to the resident taxpayers of the City of Indianapolis, as required by law prior to the date of the hearing for final passage of this Ordinance.

Section 4. The following Ordinances of the Common Council passed in the year 1955, to-wit: Appropriation Ordinance No. 22 and General Ordinance No. 111 hereby are repealed.

Section 5. This Ordinance shall be in full force and effect after due notice is given to taxpayers, the absence of a taxpayers' remonstrance thereafter, passage by the Council and approval by the Mayor, as by law required.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.
