Also, to include Keystone Avenue from the north property line of Prospect Street to the south property line of Southeastern Avenue, with a maximum property line width or right-of-way width of sixty (60) feet, and a maximum roadway or pavement width of fifty (50) feet.

Section 2. That Section 11-203 of Title 11, Chapter 2 of the Municipal Code of Indianapolis, 1951, and in particular the map designated "Official Thorofare Plan of the City of Indianapolis", which is made a part of said Chapter 2 by reference, be and the same are hereby amended and changed so as to establish and provide for a maximum property line width or right-of-way width of sixty (60) feet and a maximum roadway or pavement width of fifty (50) feet in Rural Street, from the north line of Hoyt Avenue to the south line of 25th Street.

Section 3. That all copies of the Official Thorofare Plan be amended and changed so as to include the revisions as set forth in Sections 1 and 2 hereof.

INTRODUCTION OF SPECIAL ORDINANCES

SPECIAL ORDINANCE NO. 7, 1958

By Councilman Williamson:

AN ORDINANCE changing the name of the street known as 33rd Street, between LaSalle Street and Olney Street.

WHEREAS, it has become apparent that there are two parallel streets, both known as 33rd Street, immediately east of George Washington Park, in the City of Indianapolis.

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the name of the first street south of and parallel with 34th Street, between LaSalle Street and Olney Street, running along the south line of Washington Village Addition, and presently known as 33rd Street, be and the same is hereby changed to Laney Street.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

Which was read for the first time and referred to the Committee on Public Health.
