## GENERAL ORDINANCE NO. 96, 1958

AN ORDINANCE establishing certain passenger and/or loading zones in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owner or occupants of certain premises fronting on certain public streets in the City of Indianapolis, with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as Amended, Section 4-1001, and the Board of Public Safety, after due investigation, having recommended the establishment of the same, the following passenger and/or loading zones be, and the same are, hereby established in the City of Indianapolis, to-wit:

- (a) Beginning at a point on the southeast curb line of the first alley north of Ohio Street and extending 20 ft. southwest on the southwest side of Massachusetts Avenue for the use and occupancy of Kittles the Good Housekeeping Store, 229 Massachusetts Avenue.
- (b) Beginning at a point 219 ft. northeast of the west property line of Capitol Avenue and extending 50 ft. northeast on the northwest curb line of Kentucky Avenue for the use and occupancy of the Red Cab, Inc., 2020 North Illinois St.
- (c) Beginning at a point 92 ft. south of the South Curb Line of Washington Street and extending 25 ft. south on the west side of Senate Avenue for the use and occupancy of Miller Carpet and Rug Outlet, 303 West Washington Street.

Section 2. That said loading zones are hereby declared to be

subject to all existing traffic and parking regulations, and to any later ordinances and regulations as may be applicable.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and compliance with all laws pertaining thereto.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City of Indianapolis, Indiana, be and the same is hereby extended so as to include the following described territory in Lawrence Township, Marion County, which is hereby annexed to and made a part of the territory constituting the City of Indianapolis, Indiana, and described as follows, to-wit:

Beginning at the point of intersection of the South right-of-way line of East 46th Street and the West right-of-way line of North Arlington Avenue, running thence North on and along the West right-of-way line of North Arlington Avenue to the South line of the First Section of Arlington Park, as per plat thereof recorded in the Office of the Recorder of Marion County, Indiana; thence West on and along the South line of said Arlington Park First and Second Sections to the Southwest corner of the said Arlington Park Second Section; thence North to the Northwest corner of the said Arlington Park Second Section; thence East on and along the North line of the said Arlington Park Second Section and First Section to the East right-of-way line of North Arlington Avenue; thence South on and along the East right-of-way line of the said North Arlington Avenue to the South right-of-way line of East 46th Street; thence West across the right-of-way of the said North Arlington Avenue to the point of beginning.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

SPECIAL ORDINANCE NO. 19, 1958

Green Pastures, per plat thereof recorded in Plat Book 27, Page 139, Office of Recorder, Marion County, Indiana.

Also, a part of the south half of the right-of-way of Troy Avenue, beginning at the southwest corner of the aforesaid southeast quarter of the southwest quarter of Section 20; thence east with the south line of said quarter quarter section to a point 530 feet west of the east line thereof; thence south to the south right-of-way line of Troy Avenue; thence west with said south right-of-way line to the west line of said quarter quarter section produced south; thence north to the place of beginning.


