Gentlemen:

I have this day approved with my signature and delivered to the City Clerk, Mrs. Teresa Laffey, the following City Ordinances.

APPROPRIATION ORDINANCE NO. 25, 1960

An ordinance to amend the Budget of the City of Indianapolis

for the year 1960, created by virtue of General Ordinance No. 75, 1959, as amended, transferring the sum of Six Hundred Ninety-seven Dollars (\$697.00), from certain items and funds in the Department of Public Safety, Weights & Measures, to certain other items and funds in the same department, declaring an emergency and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 68, 1960

An ordinance establishing a certain passenger and/or loading zone in the City of Indianapolis, pursuant to the provisions of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 82, 1960

An ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8, Section 4-812 thereof, by the addition of subsections thereto prohibiting parking at all times on certain designated Streets between certain designated points, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 83, 1960

An ordinance authorizing the Board of Public Safety of the City of Indianapolis to purchase through its duly authorized Purchasing Agent, certain equipment to be paid for out of funds heretofore appropriated or available, and fixing a time when the same shall take effect.

SPECIAL ORDINANCE NO. 53, 1960

An ordinance annexing certain contiguous territory of the City of Indianapolis, and fixing a time when the same shall take effect.

SPECIAL ORDINANCE NO. 54, 1960

An ordinance annexing certain contiguous territory of the City of Indianapolis, and fixing a time when the same shall take effect.

RESOLUTION NO. 8

Petition by the Town of Southport to the Common Council of the City of Indianapolis, Indiana for its consent to annex certain contiguous territory.

Gentlemen:

I have withheld my signature from SPECIAL ORDINANCE NO. 51, 1960 AS AMENDED, "AN ORDINANCE annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect," and SPECIAL ORDINANCE NO. 52, 1960, "AN ORDINANCE annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect," for the reason that these Ordinances provide for annexation of territory which is not at all in accordance with the over-all annexation program developed with City and Township officials.

Members of the Common Council participated in discussions of this over-all plan and realize the importance of carrying out a carefully planned program of annexation.

It appears to me that this annexation was merely an attempt to assist some party in acquiring a liquor license. Whether or not the foregoing is true these areas do not logically belong in the City of Indianapolis at this time.

## INTRODUCTION OF APPROPRIATION ORDINANCE

By Councilman Huber:

### APPROPRIATION ORDINANCE NO. 26, 1960

AN ORDINANCE to amend the Budget of the City of Indianapolis, for the year 1960, created by virtue of General Ordinance No. 75, 1959, as amended, transferring the sum of Five Thousand Dollars (\$5,000.00), from a certain item and fund in the Department of Public Works, Street Commissioner, to a certain other item and fund in the same department, declaring an emergency and fixing a time when the same shall take effect.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget, and certain monies appropriated for certain accounts of the Department of Public Works, Street Commissioner, are insufficient to meet current needs of the program of said department, and

WHEREAS, certain existing appropriations for said department now have unobligated balances which will not be needed for the purpose for which appropriated, and

WHEREAS, it is in the best interest that funds be transferred from a certain item and fund in the same department because of an existing emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a certain item and fund in the Budget of the



Department of Public Works, Street Commissioner, is hereby reduced and transferred to another item and fund in the same department, as follows, to-wit:

BOARD OF PUBLIC WORKS  
STREET COMMISSIONER

REDUCE:	Tax Levy
3. SUPPLIES	
33. Garage and Motor -----	\$5,000.00

INCREASE:	
4. MATERIALS	
45. Repair Parts -----	\$5,000.00

Section 2. The above transfer is necessary because of an existing emergency due to breakdowns of heavy equipment, graders, sweepers and Hough Front End Loaders, for which repair parts are very costly.

Section 3. That said appropriation does not involve any increase in the annual budget of the City of Indianapolis.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

INTRODUCTION OF GENERAL ORDINANCE

GENERAL ORDINANCE NO. 86, 1960

AN ORDINANCE approving the acceptance of a proposition to purchase real estate and authorizing the expenditure of money for the acquisition of additional ground for the extension of the Municipal Garage.

WHEREAS, the City of Indianapolis has need for additional land adjacent to its present facilities for maintenance of its police, fire, and other vehicles and equipment, and

WHEREAS, the Elmore Agency, as agent for Immaunel Methodist Church, has given a proposition to sell to the City, a portion of Lot No. 1, Square 39, of the donation lands of the City of Indianapolis, which tract is rectangular in shape with sides measuring 120 feet and 67.6 feet, which tract is situated at the Southwest corner of the intersection of East New York Street and North New Jersey Street, in the City of Indianapolis, for the sum of Twenty-five Thousand Dollars (\$25,000.00), in cash, and

WHEREAS, said proposition and offer is made subject to the approval of the Indianapolis Common Council referred to in the option as the "City Council," and

WHEREAS, the Board of Public Works of the City of Indianapolis has represented and shown to this Council that the new City-Council Building does not have facilities for the maintenance and repair of city equipment and motor vehicles and the present Municipal Garage is in need of expansion, and the real estate to be acquired is immediately adjacent to and east of said Municipal Garage, and

WHEREAS, the title holders desire an expression of the Common Council of the City of Indianapolis as to its intent to approve a proposition to purchase said real estate upon said terms.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Common Council does hereby approve the proposition described in the preamble to purchase said real estate out of funds for such purchase provided heretofore for land acquisition by this Common Council in the budget of the Department of Public Works for the year 1961, and authorizes the purchase of said real estate at an expenditure of Twenty-five Thousand Dollars (\$25,000.00) out of 1961 funds.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read for the first time and referred to the Committee on Finance.
