Indianapolis January 9th 1851

Council met, Present, Messrs McOuat, Landis, Hetselgessen, Eckert and Mr President.

The Committee appointed to settle with John S. Spann the late Treasurer, made the following Report, which was accepted by the Council.

Road Fund " "	281.53

We the Committee appointed to settle with the late Treasurer, certify that we have examined the Books and accounts of his office, and certify that we find all correct. The above is a statement of the present situation of the various funds, (subject to the Treasurers per centage) at this date.



The Treasurer elect, James H. Kenneday presented his bond which was accepted by the Council with the addition of the word "Moneys" inserted therein, was sworn into office, and entered upon the discharge of the duties thereof.

(269) The Bill of Mr Evans amounting to the sum of \$40.80/100 was presented to the Council and on motion the whole bill was rejected except so much as related to extra wall for one of the public school houses which later amounting to the sum of \$10.00 was allowed.

The following resolution offered by Mr. McOuat, and adopted.

Resolved, That the Religious Society denominated the United Brethern be allowed the privilege of holding worship in the School House in Ward No 1, in the City of Indianapolis on Sabbath days and evenings, Provided, they keep the premises and House in good repair, and become respncible for any damage done thereto, and that the Council reserves the



privilage of recinding or annulling this grant at any time hereafter, if they see proper so to do.

(404) Mr Hetselgessen moved that the sum of \$4.00 be allowed to John McCollum as interest due him on a \$200. order, which has been cancelled by the Council and smaller ones issued in lieu thereof which motion did not Prevail.

Mr Eckert, laid before the Council the Certificate of sale of Lot No 8. in square No 127, sold to J. M. W. Langsdale; said Lot belonging to the State, he moved that the amount of \$1.55 be refunded to said Langsdale, and the Certificate cancelled, which motion prevailed.

Mr Eckert offered the following Resolution which was adopted.

Resolved, That all orders hereafter issued by the Secretary, shall be attested by the secretary and countersigned by the President and if not no attested and countersinged, the Treasurer is not authorised to receive them.

The Bill of Beck, Cornelius and Adans, signed by the City Engineer and Street Commissioner for work done on Kentucky Avenue, was presented, with the following Report from the Committee on Streets, which were severally approved bf by the Council.

The Secretary of the City Council is hereby authorised to issue to William M. Beck, Benson Cornelius and H. F. Adams, City orders to the amount of \$147.¹⁴₁₀₀, it appearing from the City Engineers estimate, that, that amount is due them, but nothing herein is to be considered as a release to them from finishing the Street as per contract, whenever the undersigned Committee order the same to be done.

to the Contractors for the 3rd instalment due for buildin School Houses.

Indianapolis January 31st 1850

The Council met, Present, Messrs Landis, Eckert, Loudon Hetselgessen and Mr Cully President.

The object of the meeting was the consideration of Mr Lockwood's proposition to light the City with gas, and an ordinance presented by him granting him the privilage, And on Motion of Mr Eckert the subject was refered to a select Committee, said Committee was appointed by the President, and consists of the following named Councilman to.wit, Messrs Eckert, Landis and McQuat

A petition signed by N. Teal asking the Council to grant him the privilage of selling goods wares and merchandise at Auction within the limits of the City was read, and on motion of Mr Loudon, the Council authorised the Secretary to issue a license to said Teal as Auctioneer for the term of one year.
