Gentlemen:

Since the last report made by this department on March 17, 1930, the Radio Beacon Station has been practically completed, and the operator expects to have it in operation in a few weeks. Although this station will be operated at the Municipal Field, it will not be necessary for the pilots to land at this field until we are ready for them. It is merely for the convenience of those using the Mars Hill Field.

Mr. Armington, the local representative of the United States Weather Bureau, informs me that he has been supplied with equipment to install a complete Weather Bureau at the Municipal Field. This will include upper air observations and the hourly weather reports from all over the United States. This service is gratis, and in return space has been provided on the second floor of the Administration Building for the Weather Bureau offices.

Plans and specifications for all work except the field lighting and fueling equipment are now on file in the office of the Board of Works, and bids are being asked for at this time. This contract will be awarded

shortly after May 5th, and the contractor should be at work within a few days after this date.

The lighting and fueling systems are now being designed and specifications written by the Rotz Engineering Company, and we expect to receive bids on these two systems some time during the early part of May.

The building construction is progressing very nicely, about half of the basement being excavated at this time, and the concrete for part of the footings has been poured.

The 12-inch well that has been contracted for is now being sunk, and it is expected that this work will be completed within the next thirty days.

INTRODUCTION OF GENERAL ORDINANCE

By City Plan Commission:

GENERAL ORDINANCE No. 37, 1930

AN ORDINANCE to amend General Ordinance No. 114, 1922, commonly known as the Zoning Ordinance.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U3 or business district, the A3 or 2,400 square foot area district and the H1 or 50 foot height district be and the same are hereby amended, supplemented and extended so as to include the following described territory:

Beginning at a point on the north property line of 10th street at a point 130 feet east of the east property line of Arlington avenue; thence north a distance of 126.93 feet to a point; thence west parallel to the north property line of 10th street to a point 175 feet west of the west property line of Arlington avenue; thence south and parallel to the east property line of Arlington avenue to a point 124 feet south of the south property line of 10th street; thence east and parallel to the south property line of 10th street to a point in the east property line of Arlington avenue; thence south on and along the east property line of Arlington avenue a distance of 26 feet to a point; thence east and parallel to the south property line of 10th street a distance of 170.67 feet to a point; thence north a distance of 150 feet to a point in the south property line of 10th street; thence west on and along the south property line of 10th street a distance of 40.04 feet to a point; thence north a distance of 90 feet to the point or place of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

AN ORDINANCE transferring money from certain numbered funds in the Department of Public Health and Charities of the City of Indianapolis, Indiana, and reappropriating the same to other numbered funds of said department; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Health of the City of Indianapolis be and it is hereby authorized to purchase ten thousand (10,000) tons of coal, more or less, for use and in connection with the Indianapolis City Hospital for a period from May 1, 1930, to April 30, 1931.

A MOTION TO AMEND GENERAL ORDINANCE No. 35, 1930

I move that General Ordinance No. 35, 1930, be amended as follows:

By striking out the words and figures in the first and second lines of the preamble, "Eighty-seven Thousand Dollars (\$87,000.00)" and "eighty-seven (87)," and substituting therefor the words and figures "Ninety Thousand Dollars (\$90,000.00)" and "ninety (90)."

By adding the following paragraph between lines 11 and 12 at page 2 of the ordinance: "Whereas, Certificates numbered S-167, 168, 169 and 170 have been issued by the Board of Public Works of the City of Indianapolis and the City Controller of said city, pursuant to Chapter 184 of the Acts of the General Assembly of the State of Indiana for

the year 1927, to the Krenn & Dato Building and Construction Company, said certificates being issued pursuant to a resolution of the Board of Public Works heretofore adopted on the day of , 1930, said certificate calling for interest at the rate of six per cent (6%) per annum from the date of issue and being in the principal amount of Three Thousand Three Hundred Seventy-four Dollars and Sixty-six Cents (\$3,374.66). That the amount of interest on said certificates from the date of issue to June 30, 1930, is Two Hundred Fifty Dollars and Seventy-four Cents (\$250.74), making a total due of principal and interest on said certificates of Three Thousand Six Hundred Twenty-five Dollars and Forty Cents (\$3,625.40)."

By striking out lines 12, 13, 14, 15, 16 and 17, beginning with the words "Whereas, The total principal" and ending with the words "is required to pay and," and substituting therefor the following: Whereas, The total principal amount of said certificates heretofore described amounts to Eighty-seven Thousand Four Hundred Twenty-three Dollars and Fourteen Cents (\$87,423.14) with interest thereon up to and including June 30, 1930, of Two Thousand Seven Hundred Sixteen Dollars and Twelve Cents (\$2,716.12), which said interest the city is required to pay."

By striking out at lines 4 and 5 of the last paragraph, on page 2, the words and figures "Eighty-seven Thousand Dollars (\$87,000.00)," and substituting therefor the words and figures "Ninety Thousand Dollars (\$90,000.00)."

By striking out at line 5 of Section 1 of the ordinance, at page 3 thereof, the words and figures "eighty-seven (87)," and substituting therefor the words and figures "ninety (90)."

By striking out at line 9 of Section 1 of the ordinance, on page 3 thereof, the words and figures "one (1) to eighty-seven (87)," and substituting therefor the words and figures "one (1) to ninety (90)."

By striking out the following at line 16 of Section 1 of the ordinance, at page 3 thereof: "The first thirteen (13) series shall consist of four (4) bonds of One Thousand Dollars (\$1,000.00) each; the following seven (7) series shall consist of five (5) bonds of One Thousand Dollars (\$1,000.00) each," and substituting therefor the following: "The first thirteen (13) series shall consist of four (4) bonds of One Thousand Dollars (\$1,000.00) each; the following four (4) series shall consist of five (5) bonds of One Thousand Dollars (\$1,000.00) each; and the following three (3) series shall consist of six (6) bonds of One Thousand Dollars (\$1,000.00) each."

By striking out lines 1, 2, 3, 4, 5, 6, 7, 8 and 9 of the third paragraph of the ordinance, at page 5 thereof, beginning "This bond is one of" and ending "each year for the following seven (7) years," and substituting therefor the following: "This bond is one of an issue of ninety (90) bonds of One Thousand Dollars (\$1,000.00) each, numbered from one (1) to ninety (90), both inclusive, of date of June 30, 1930. Said bonds shall mature in series of four (4) bonds of One Thousand Dollars (\$1,000.00) each, each year for the first thirteen (13) years, the first series of four (4) bonds maturing July 1, 1932; five (5) bonds of One Thousand Dollars (\$1,000.00) each, each year for the following four (4) years; six (6) bonds of One Thousand Dollars (\$1,000.00) each, each year for the following three (3) years."

The motion was seconded by Mr. Welch and passed by the following roll call vote:

Ayes, 9, viz.: Mr. Gardner, Mr. Henry, Mr. Hildebrand, Mr. Houck, Mr. Morgan, Mr. Tennant, Mr. Welch, Mr. Wheatley, President Ropkey.

On motion of Mr. Houck, seconded by Mr. Wheatley, General Ordinance No. 35, 1930, as amended, was ordered engrossed, read a third time, and placed upon its passage.

General Ordinance No. 35, 1930, as amended, was read a third time by the Clerk and passed by the following roll call vote:

Ayes, 9, viz.: Mr. Gardner, Mr. Henry, Mr. Hildebrand, Mr. Houck, Mr. Morgan, Mr. Tennant, Mr. Welch, Mr. Wheatley, President Ropkey.

MISCELLANEOUS BUSINESS

Mr. Hildebrand announced that the Committee on Public Works was not ready to report on General Ordinance No. 17, 1930, and asked for further time for consideration of said ordinance, which was granted.

Mr. Tennant announced that the Committee on Public Safety was not ready to report on General Ordinance No. 32, 1930, and asked for further time for consideration of said ordinance, which was granted.

Mr. Hildebrand announced that the Committee on Public Works was not ready to report on General Ordinance No. 34, 1930, and asked for further time for consideration of said ordinance, which was granted.

On motion by Mr. Wheatley, seconded by Mr. Henry, the Common Council adjourned at 8:45 p. m.
