Monday, May 1st, 1961

The Common Council of the City of Indianapolis, met in the Council Chamber in the City Hall, Monday, May 1st, 1961 at 7:30 P.M. in regular session. President Wallace in the chair.

The Clerk called the roll.

standing of vehicles on certain streets between the hours of 3:00 P.M. and 4:00 P.M. on each day of the week except Saturdays, Sundays and holidays and fixing a time when said amendments shall take effect.

WHEREAS, the State Board of Tax Commissioners has requested that the Common Council take such requisite action.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication according to law.
