WHEREAS, certain existing appropriations for said department

now have unobligated balances which will not be needed for the purpose for which appropriated.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a certain item and fund specifically budgeted in the Department of Public Works, Street Commissioner, be and the same is hereby reduced in the following amount, to-wit:

and said amount is transferred therefrom, reappropriated and re-allocated to the following designated item and fund.

INCREASE TAX LEVY

3. SUPPLIES

38. General Supplies -----\$35,000.00

Section 2. The above transfer and reappropriation is necessary because of an existing emergency. Due to the extreme winter weather the excessive treatment of streets and bridges for removal of ice and snow has exhausted the surplus for the 1963-1964 program and for other needs such as rakes, shovels, etc.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

INDIANAPOLIS CITY RECORDS

4-814.2, prohibiting parking at all times except Sundays on certain streets, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 8, of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the addition thereto of the following Section 4-814.2 as follows:

4-814.2—Parking prohibited at all times, except on Sundays on certain Streets.

It shall be unlawful for any driver or operator of any vehicle to park same, or to permit the same to be parked at any time, except on Sunday, and except or otherwise permitted in this title in any of the following places:

Section 2. This amendment shall be subject to the penalties as provided in Title 4, Chapter 8, Section 4-831 of the Municipal Code of Indianapolis, Indiana, 1951, as amended.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, compliance with all laws pertaining thereto and publication as required by law.
