APPROPRIATION ORDINANCE NO. 2, 1963

An Ordinance, appropriating the sum of One Thousand Dollars (\$1,000.00), from the unexpended and unappropriated balance of the General Fund of the City Indianapolis, and transferring the same to Civil Defense, Temporary Salaries, Fund No. 12.

GENERAL ORDINANCE NO. 20, 1963

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8 thereof, by the deletion and repeal of a subsection to Section 4-812, which prohibits parking at any time on a certain street and fixing a time when said amendment shall take effect.

GENERAL ORDINANCE NO. 21, 1963

An Ordinance to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 8 thereof, by the addition of a subsection to Section 4-834.1, prohibiting parking, stopping or standing between 6:00 A.M. and 9:00 A.M. inclusive and 3:00 P.M. and 6:00 P.M. inclusive, excepting Saturdays and Sundays on certain designated streets, providing a penalty for the violation of same and fixing a time when said amendment shall take effect.

INTRODUCTION OF APPROPRIATION ORDINANCE

APPROPRIATION ORDINANCE NO. 4, 1963

AN ORDINANCE, appropriating, transferring, reappropriating and reallocating the sum of Twelve Hundred Dollars (\$1,200.00), from a certain specific, designated item and fund in the Department of Law, to a certain other designated item and fund in the same department, created by virtue of the 1963 Budget, General Ordinance No. 66, 1962, declaring an emergency and fixing a time when the same shall take effect.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing Annual Budget, and certain monies appropriated for certain accounts of the Department of Law are insufficient to meet the current needs of the department, and

WHEREAS, certain existing appropriations for said department now have unobligated balances which will not be needed for the purpose for which appropriated.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a certain item and fund specifically budgeted in the Department of Law, be and the same is hereby reduced in the following amount, to-wit:

and said amount is transferred therefrom, reappropriated and reallocated to the following item and fund.

Section 2. The above transfer and reappropriation is necessary because of an existing emergency in that there has occurred a need for printing, particularly for affidavits charging city ordinance violations in the City Prosecutor's office, in certain areas where ordinance enforcement has become vital in the current year, and which was not discernable at the time the budget was made in 1962.

Section 3. That the department of law will abstain and withhold expenditures from its equipment fund in order to provide a transfer of funds therefrom, thereby avoiding any actual increase in the ordinance budget.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor, and publication and notice as by law required.

Section 1. That there be added to the Municipal Code of Indianapolis, a new and additional section to be known as Section 8-219 and which Section shall read as follows:

SECTION 8-218. **Special Permission Wood Shingle Roofs.** When it shall appear that a building permit is sought from the Building Commissioner and where shingle roofs have been provided in the plans, where such shingle roofs have been adequately treated for fire resistance and where such wood shingle roof is part of a commercial scheme, or part of a business or advertising plan, or, the building is a reproduction of a historical period, or where the same shall constitute special or unusual architectural design, the Building Commis-

sioner of the city, notwithstanding the provisions of Section 8-218 of this Code, may grant a building permit for such special wood shingle roof, and may consult in reference to such special permit, the Fire Prevention Bureau of this city.
