- WHEREAS, there are no existing funds available for the payment of such further study and survey, and
- WHEREAS, The Board of Public Safety deems it advisable that funds be provided so that said study may continue, and
- WHEREAS, this is a contingency which could not be foreseen at the time of the making of the budget for the current year, and
- WHEREAS, by the foregoing facts, an Emergency is deemed to exist,

NOW, THEREFORE, BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

That certain funds in the Indianapolis Police Department of the Board of Public Safety be reduced, and the amount so reduced be transferred to another fund as follows, to-wit:
