AN ORDINANCE, appropriating, transferring, reappropriating and reallocating the sum of Three Thousand Dollars (\$3,000.00), from a certain specific, designated item and fund in the Department of Public Safety, Fire Department, to a certain other designated item and fund in the same department, created by virtue of the 1963 Budget, General Ordinance No. 66, 1962, declaring an emergency and fixing a time when the same shall take effect.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing Annual Budget, and certain monies appropriated for certain accounts of the Department of Public Safety, Fire Department, are insufficient to meet the current needs of the Department, and

WHEREAS, certain existing appropriations for said department now

have unobligated balances which will not be needed for the purpose for which appropriated.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a certain item and fund specifically budgeted in the Department of Public Safety, Fire Department, be and the same is hereby reduced in the following amount, to-wit:

FIRE DEPARTMENT

REDUCE:	TAX LEVY
1. SERVICES—PERSONAL	
11. Salaries and Wages, Regular -----	\$3,000.00

and said amount is transferred therefrom, reappropriated and reallocated to the following item and fund.

INCREASE:	TAX LEVY
3. SUPPLIES	
34. Special—Clothing and Equipment Allowance -----	\$3,000.00

Section 2. The above transfer and reappropriation is necessary because of an existing emergency. In 1962 the City Council cut Fund 34 from \$155,000.00 to \$151,000.00. The clothing allowance for the past July and the anticipated second installment in December will be in the amount of at least \$149,099.92, and in addition to this, twenty new men will have to be outfitted this year at an amount of \$4,365.00, making it necessary to transfer the amount of \$3,000.00. That such was not foreseeable when the Annual Budget was made.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor, and publication and notice as by law required.

(1.) There shall be a minimum space between housing on adjacent lands of not less than thirty (30) feet, or in the event there is no residential improvement on adjacent lands, then there shall be provided a minimum distance of not less than fifteen (15) feet between house and sidelot line;

(2.) Any dwelling upon which is proposed a wood shingle roof shall have a maximum height of thirty-five (35) feet;

(3.) Any dwelling upon which is proposed a wood shingle roof shall be constructed upon a lot having not less than 10,000 square feet minimum lot area, in the case of a single-family dwelling, and 15,000 square feet in the case of a two-family dwelling.
