TO ALL MEMBERS OF THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS:

Gentlemen:

As you probably know, the 1963 Session of the General Assembly of Indianapolis passed an Act permitting the construction of a Civic Center in counties having a city of first-class providing the matter is approved by the electorate of the county at a county election. The law requires that the governing bodies of the city and county shall both pass Resolutions requesting a joint hearing to decide if the matter shall be placed before the electorate and go on the ballot for a referendum.

During 1963 both the City and the County passed such a Resolution. The law further states when such Resolution have been passed, the County Auditor shall cause a notice to be published once each week for two weeks in two newspapers for general circulation in the county setting out the time and place of a joint hearing.

If, after such a public hearing, the governing body shall determine that the public interest will be promoted by the construction of a Civic Center, a concurrent Resolution to such effect is to be separately adopted by both governing bodies.

Mr. John T. Sutton, the Auditor of Marion County, has called a joint meeting to hold a public hearing on the matter. The hearing

date has been set for Monday, February 10th, 1964 at 7:30 P.M. in the public assembly room in the City-County Building. Notice of the meeting is to be published on January 10th and 17th in the Indianapolis News and the Indianapolis Commercial. It is therefore suggested that all members of the City Council hold the date and time in reserve on their schedule for the public meeting. Mr. Sutton has asked that I notify the members of the Council at this time so they can plan to be present as the hearing will be of great importance to the citizens of Marion County.

**GENERAL ORDINANCE NO. 14, 1964**

AN ORDINANCE creating and establishing in the government of the City of Indianapolis the position of Director of Public Safety.

**BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:**

Section 1. Director of Public Safety. There is created and established in the Department of Public Safety the position to be known as "Director of Public Safety."

Section 2. Qualifications. The person appointed and holding such position shall have had experience in law enforcement, crime preven-

tion, public safety, investigative or security work sufficient to merit a standing as being a qualified expert in such field.

Section 3. Duties. It shall be the duty of such Director of Public Safety to collaborate with the Chief of Police in implementing the reorganization and the realignment of the Indianapolis Police Department using the basic 1963 study of Indiana University as a basic starting point and to keep such Department in line with later and continued police studies from any and all other sources. Said Director of Public Safety shall constantly evaluate police and safety procedures and methods and make the most efficient use of the personnel of such department and to carry out in such department the policies and the plans of the Mayor of such City for law enforcement methods and procedures.

Section 4. Authority to Combine and Assign Functions. Said Director of Public Safety shall constitute and be a liaison between the Executive Departments including the Mayor and other administrative agencies. Said Director of Public Safety may have assigned to him any existing functions or future functions including the Direction of personnel in said Department of Public Safety, and the taking over of any other regulatory duties and may replace any existing functions and duties including personnel supervision and regulatory work in the Department of Public Safety and the Police Department.

Section 5. Purpose of Office. The purpose of such office and position shall be the promotion of law enforcement and the bringing about of public safety in every field in the City of Indianapolis, under the policies and direction of the Mayor in this respect.

Section 6. Appointment and Duration of Term. Said Director shall be appointed solely by the Mayor and shall serve only at the pleasure of the said Chief Executive of the City of Indianapolis.

Section 7. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

GENERAL ORDINANCE NO. 15, 1964

AN ORDINANCE, transferring, reappropriating and reallocating the sum of Eleven Thousand (\$11,000.00) Dollars in the Department of Public Safety, Police Department, to provide for the compensation of the Director of Public Safety.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. There is hereby provided the sum of Eleven Thousand (\$11,000.00) Dollars as compensation and salary for the position of Director of Public Safety. To furnish such salary General Ordinance No. 58, 1963, the City's Annual Budget for 1964, is amended as follows:

DECREASE TAX LEVY

DEPARTMENT OF PUBLIC SAFETY POLICE DEPARTMENT

- 1. SERVICES—PERSONAL
  - 11. Longevity Pay .....\$11,000.00

and

INCREASE TAX LEVY

DEPARTMENT OF PUBLIC SAFETY ADMINISTRATION

- 1. SERVICES—PERSONAL
  - 11. Salaries and Wages, Regular
    - 1 Director of Public Safety .....\$11,000.00

Section 2. This ordinance and the reallocation herein does not increase the Annual Budget, or affect the tax rate but merely shifts classification, within a budget item without any effect on the total.



Section 3. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor and constitutes an inter item transfer and the holder of such position shall be entitled to the full salary thereof during such service even though the same should begin after the outset of the 1964 calendar year.

AN ORDINANCE annexing certain contiguous territory to the City of Indianapolis, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the City of Indianapolis, Indiana be and the same is hereby extended so as to include the following described territory which is hereby annexed to and made a part of the territory constituting the City of Indianapolis, Indiana, and described as follows, to-wit:

Part of the North West Quarter of Section 17, Township 16 North of Range 5 East in Marion County, State of Indiana, described as follows, to-wit:

Beginning at the South West corner of said North West quarter of said Section Seventeen (17), running thence East on the South line of said quarter section, fifteen hundred and four tenths feet, thence north (bearing very slightly to the east) eight hundred and eighty feet, thence West parallel with the south line of said quarter section, fifteen hundred



and ninety-seven one hundredth feet to the West line thereof, thence South on said West line eight hundred and eighty feet to the place of beginning, containing thirty and thirty-one one hundredth acres, more or less, except the East half of the right-of-way of North Post Road along the entire West side of said tract.

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

Which was read for the first time and referred to the Finance Committee.
