INTRODUCTION OF GENERAL ORDINANCES

GENERAL ORDINANCE NO. 34, 1964

Introduced by Councilman McGill:

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 13, thereof, by the addition of a subsection to Section 4-1303 (2), prohibiting trucks in excess of 10,000 lbs. on certain streets, providing a penalty for the violation of same and fixing a time when said Amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 4, Chapter 13, Section 4-1303 (2) of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the addition thereto of the following subsection as follows:

Section 2. This Amendment shall be subject to the penalties as provided in Title 1, Chapter 6, Section 1-601 of the Municipal Code of Indianapolis, Indiana, 1951, as amended.

INTRODUCTION OF SPECIAL RESOLUTION

Introduced by Councilman Hasbrook:

WHEREAS, the City of Indianapolis has failed to make any major improvements in street marking, railroad grade separation, crossing elimination, and street repair programs, and

WHEREAS, the needs to move and expedite traffic seems to be climbing in our city:

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA

Section 1. That a study commission consisting of the present members of the Indianapolis Board of Public Works, plus one Republican and two Democrat members of the Common Council, plus two private citizens appointed by the Mayor be created to study these problems and make recommendations to the Mayor and the Common Council in writing no later than December 31, 1964.

Section 2. That there is hereby appropriated the sum of \$5,000 to hire such necessary clerical and technical staff to assist the study commission in its work. Members of the study commission shall serve without compensation.

Section 3. The study commission shall include but not be limited to:

- a. Determination of the needs of the city for eliminating railroad crossings and a realistic proposal on how such problems are to be attacked on an annual basis.
- b. the kind of street signs needed, how big the needs may be, and a plan and cost estimate of how the problem could be met on a regular annual basis.
- c. what new techniques, material, and equipment are available for street repair.
- d. the feasibility of eliminating this work by the City and letting it out to private contractors.
- e. the use of radio equipped special chuckhole repair units and a study of the size and scope of the annual chuckhole repair problem and the proper size of chuckhole repair crews.

Which was read for the first time and referred to the Finance Committee.
