GENERAL ORDINANCE NO. 53, 1964

AN ORDINANCE authorizing the City of Indianapolis to make temporary loans in amounts totaling Three Million Nine Hundred

Thousand Dollars (\$3,900,000.00), for the use of the General Fund of the City of Indianapolis at specified times and for specified amounts, during the six months period beginning July 1, 1964 and ending no later than December 31, 1964, in anticipation of current taxes of the City of Indianapolis actually levied and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; empowering the controller to issue tax anticipation warrants to evidence such loan at such time and amount and for such duration as needed, providing for the legal notice of sale, and the time when said loan shall mature; and fixing a time when this ordinance shall take effect.

GENERAL ORDINANCE NO. 54, 1964

AN ORDINANCE authorizing the City of Indianapolis to make temporary loans for the General Fund of the Department of Public Parks in the amounts totaling Six Hundred Twelve Thousand Dollars (\$612,000.00), at specified times and for specified amounts, for the purpose of carrying on the functions of said Department, said loan to be made in anticipation of and payable out of the current taxes of said Department of Public Parks actually levied for the General Fund of the Department of Public Parks and in the course of collection for the fiscal year in which said loan is made payable; to be borrowed at such times and in such amounts as is needed during said period; providing for the interest to be charged therefore; providing for legal notice of temporary loan sale and the time when the said loan shall mature; and fixing a time when this ordinance shall take effect.

INTRODUCTION OF APPROPRIATION ORDINANCES

APPROPRIATION ORDINANCE NO. 9, 1964.

Introduced by Councilman Moriarty.

AN ORDINANCE appropriating the sum of Three Thousand Five Hundred Eighty (\$3,580.00) Dollars, from the 1964 anticipated and unexpended balance of the General Fund of the City of Indianapolis, to certain designated items and funds in the Office of the City Clerk, created by virtue of the 1964 Budget, General Ordinance No. 58, 1963, as amended, declaring an emergency and fixing a time when the same shall take effect.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget, so that it is necessary to appropriate more money than was appropriated in the annual budget of the Office of City Clerk, to meet such extraordinary emergencies.

NOW, THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Three Thousand Five Hundred Eighty (\$3,580.09) Dollars, from the 1964 anticipated and unexpended balance of the General Fund of the City of Indianapolis, is hereby set apart and appropriated out of said funds as follows, to-wit:

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 3, Chapter 1, Section 3-115 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the deletion and repeal thereof, as follows:

3-115—Parking limited to one hour in the City Market Parking areas, between 6:00 A.M. and 9:00 o'clock P.M., on days when the City Market is open for business.—It shall be unlawful for the owners, driver or operator of any vehicle to park or to stop such vehicle, or to permit the same to be parked or to stand for a

longer period of time than one hour, between the hours of 6:00 o'clock A.M., and 9:00 P.M., on any day when the City Market is open for public business, in the areas of the City Market reserved for free parking and designated as City Market parking areas. (G. O. 47, 1959, eff. June 2, 1959).

GENERAL ORDINANCE NO. 64, 1964

Introduced by Councilman Deluse.

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 4, Chapter 9 thereof, by the creation of parking meter zones on the City Market Parking Lots, providing a penalty for the violation of same, and fixing a time when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. The following ordinance is hereby adopted:
Section 4-931—(1) Notwithstanding other provisions of this Code pertaining to the charges for parking in parking meter zones and limitations as to parking periods therein, there is hereby created and established one and one-half (1½) hour parking meter zones with a minimum fee of 5¢ per one-half hour from 7:00 o'clock A.M. to 6:00 P.M. on all days except Sundays and holidays, on the following off-street parking lots:

- (a) The City Market lot located on the west side of the present City Market Building, bounded on the south by Market Street, on the West by Delaware Street, and on the north by the first alley north of Market Street.
- (b) The City Market lot which is covered with roof on the east side of the present City Market Building, bounded on the south by Market Street, on the East by Alabama Street and on the North by the first alley north of Market Street.

Section 4-931 (2) Notwithstanding other provisions of this Code pertaining to the collection and disposition of funds collected from the operation of parking meters, all charges collected from the operation of any parking meter located in the areas described in sub-section 4-931 (1), (a) and (b) above, shall be deposited and kept in a Special Fund, known as The City Market Parking Meter Fund, and shall be set up in the budget, approved by the Common Council, and shall be under the control, orders and direction of the Board of Public Safety, and disbursements shall be made therefrom only for the following

purposes, unless otherwise authorized by any relevant statute, or required by any contract, to-wit:

- (a) For payment of the purchase price, or rental fees and costs of installation, relocation, or removal of parking meters upon the City Market Parking lots.
- (b) For the payment of the cost of maintenance, operation, repair and all other incidental costs and expenses incurred in the operation of parking meters and the collection of moneys deposited therein. Included in said incidental costs and expenses shall be the cost of clerical and bookkeeping expenses, supplies and records and the employment of all other personnel required in the collection of moneys and the handling and keeping of records of all the charges so collected and expended.
- (c) For the payment of cost of maintenance, operation, repair and all other costs and expenses incurred in the operation of the City Market.

Section 2. This amendment shall be subject to the penalties as provided in Title 4, Chapter 9, Section 4-920 of the Municipal Code of Indianapolis, Indiana, 1951, as amended.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, compliance with all laws pertaining thereto and publication as required by law.

GENERAL ORDINANCE NO. 65, 1964

Introduced by Councilman Deluse.

AN ORDINANCE authorizing the Board of Public Safety of the City of Indianapolis to purchase through its duly authorized Purchasing Agent, parking meters to be paid for out of funds heretofore appropriated or available, or on a division of revenue basis, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Safety of the City of Indianapolis, be and the same is hereby authorized and empowered to purchase through its duly authorized Purchasing Agent, the hereinafter designated equipment to be used by the department as indicated. The said equipment is to be purchased or leased on a division or revenue basis from the lowest and best bidder, or bidders, whose bids have been received and opened in public by said Board after advertisement therefor, as provided by law, and the total cost of said equipment shall not exceed the sum of money heretofore appropriated or available for the use of said Board; and authorizing said Board to enter into a contract with the purchaser.

AN ORDINANCE to amend the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, and more particularly Title 3, Chapter 1, thereof, by the addition of a subsection to Section 3-102, regarding the location and scope of the City Market, and fixing a time when said amendment shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL
OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Title 3, Chapter 1, Section 3-102 of the Municipal Code of Indianapolis, 1951, General Ordinance No. 140, 1951, as amended, be amended by the addition thereto of the following subsection, as follows:

Sub-section

- (a) Provided however, that nothing stated in Section 3-102 shall prevent the creation of parking meters zones for motor vehicles upon any portion of the City Market parking lot which shall cause customers and others to pay a fee to park thereon.

Section 2. This amendment shall be subject to the penalties as provided in Title 3, Chapter 1, Section 3-114, of the Municipal Code of Indianapolis, Indiana, 1951, as amended.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, compliance with all laws pertaining thereto, and publication as required by law.

Which was read for the first time and referred to the Committee on Safety.

INTRODUCTION OF SPECIAL RESOLUTION

SPECIAL RESOLUTION NO. 6, 1964

Introduced by Councilman Hasbrook.

WHEREAS, no complete survey of the personnel staffing of city departments has been performed for many years, and,

WHEREAS, there is a need for a study of the staffing of various city departments, discrepancies between wage rates for personnel doing comparable work, and other aspects of personnel administration in the City of Indianapolis.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA

Section 1. That a manpower study commission consisting of private citizens be appointed by the Mayor to study the personnel of each department of the City of Indianapolis. That the study committee consist of the city personnel director and eight men or women obtained voluntarily from the ranks of private companies doing business in the City of Indianapolis. These persons to possess experience in personnel work, industrial engineering, job evaluation and job analysis. That they work as a study committee until they have surveyed each department within Indianapolis' city government.

Section 2. The study commission should make written reports and recommendations to the Mayor and the members of the City Council on or before July 1, 1965, concerning but not limited to the following:

- a. wage policies—present and recommended.
- b. adequacy or inadequacy of the staffing of each department.
- c. physical requirements and physical examinations needed.
- d. establishment of a job analysis and job evaluation system for all city jobs.
- e. discrepancies in employee benefits which may exist including vacation policies and any others.
- f. establishment of a performance rating system for city employees and a system for reviewing the same.
- g. any other aspects of personnel administration which may result in a more efficient staff of city employees serving the community.

Which was read for the first time and referred to the Committee on Finance.
