

# PROCEEDINGS OF COMMON COUNCIL.

REGULAR SESSION—AUGUST 19, 1889.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, August 19th, A. D. 1889, at eight o'clock, in regular session.

PRESENT—Hon. Caleb S. Denny, Mayor, and *ex officio* President of the Common Council in the Chair, and 16 members, viz.: Councilmen Burns, Cummings, Darnell, Davis, Elliott, Gaul, Johnston, Kelley, Long, Markey, McClelland, Pearson, Stuckmeyer, Thalman, Trusler, and Wilson.

ABSENT, 9—viz: Councilmen Coy, Dunn, Finch, Gasper, Hicklin, O'Connor, Parkinson, Smith, and Swain.

The Proceedings of the Common Council for the regular session held August 5th, 1889, having been printed and placed on the desks of the Councilmen, said Journals were approved as published.

## OPENING AND REFERRING SEALED PROPOSALS FOR PUBLIC IMPROVEMENTS.

Sealed proposals for the following street improvements were opened, read, and referred to the Committee on Contracts:

For grading and graveling Carter street and sidewalks, from Randolph street to Wolcott street.

For grading and bowldering the north gutter of Second street, and curbing with stone and paving with brick the sidewalk thereof, from Illinois street to Tennessee street.

For the construction of a brick sewer, two and one-half ( $2\frac{1}{2}$ ) feet internal diameter, in and along Broadway street and Christian avenue, from the north line of Cherry street to the west line of Central avenue.

For grading, bowldering and curbing the north gutter of Second street, and paving with brick the sidewalk thereof, from Illinois street to Meridian street.

For grading and graveling Tenth street and sidewalks, from Illinois street to Meridian street.

For grading and graveling Columbia avenue and sidewalks, from the State Ditch to the Belt Railroad.

For grading and graveling Iowa street and sidewalks, from Chestnut street to East street.

For grading and graveling Raymond street and sidewalks, from the west line of East street to the east line of Singleton street.

For grading and graveling Nevada street and sidewalks, from Hillside avenue to Sheldon street.

For grading and paving with brick the southeast sidewalk of Kentucky avenue, from South street to Merrill street, where not already paved.

For grading and paving with brick the south sidewalk of Indiana avenue, from Ohio street to the Canal.

For grading and paving with brick the south sidewalk of Tenth street, from Tennessee street to Illinois street.

For grading and graveling the first alley east of East street, from Gresham street to Morton street.

For grading and graveling the first alley south of Gresham street, from the first alley east of East street to Gray street.

For grading and paving with brick the south sidewalk of Sixth street, from Delaware street to Alabama street.

For grading and bowldering the first alley north of Louisiana street, from East street to New Jersey street.

For grading and paving with brick the west sidewalk of New Jersey street, from South street to Merrill street.

For re-grading and paving with cement, the sidewalks on the east and north sides of what is known as "Military Park," from the Canal, on the west side of West street, north to New York street; thence on the south side of New York street from West street to Blackford street.

For grading and graveling the first alley east of Park avenue, from Eighth street to Ninth street.

For grading and paving with brick the west sidewalk of Pennsylvania street, from Tenth street to Eleventh street.

For grading and graveling Frank street and sidewalks, from Jefferson street to Prospect street.

For grading and paving with brick the south sidewalk of Pratt street, from Meridian street to Illinois street, where not already done.

For grading, paving with Filbret Vulcanite Pavement, the roadway of Pennsylvania street, bowldering between the rails of the tracks of the Citizens' Street Railroad, curbing with stone the gutters thereof, from the north line of Washington street to the south line of Ohio street, and requiring the Citizens' Street Railroad Company to pay a portion of the costs thereof, as provided for in General Ordinance No. 4, 1884.

Councilman Pearson moved that the Committee on Contracts be requested to report at this session on the bids referred to them for the improvement of Pennsylvania street with Filbert Vulcanite Asphaltic Pavement, from the north line of Washington street to the south line of Ohio street.

Which motion was adopted.

#### COMMUNICATIONS, ETC., FROM THE MAYOR.

His Honor, the Mayor, submitted the following report; which was received:

To the Council and Board of Aldermen :

*Gentlemen.*—I this day received from Roger R. Shiel the sum of \$1,666.66, as the cash payment on the Indiana avenue property. Mr. Shiel also executed his two notes for \$1,666.67 each, due in one and two years, at six per cent. interest, and a mortgage to secure the same. SIR:—The following resolution, duly passed by the Common Council and concurred in by the Board of Aldermen, by reference to the undersigned Committee on Judiciary and City Attorney, with power to act :

"WHEREAS, It is admitted by the City Civil Engineer that no natural gas service pipe connections are now being inspected by any deputy of this Department; and whereas, many of such connections are now being made by the natural gas companies; and whereas, such inspection is explicitly required by General Ordinance No. 10, 1888, and that this city is daily laid liable to expensive damage suite on account of said dereliction of said inspection duties; therefore

*Resolved*, That the City Civil Engineer is hereby ordered to rigidly enforce said ordinance as regards said inspections of service pipes, and is authorized to employ natural gas inspectors, not to exceed two in number, should his present force prove inadequate to perform such duties."

We recommend that the resolution be complied with, and that you rigidly enforce the natural gas ordinance requiring the inspection of service pipes; and if your present force is inadequate to perform this duty, that you appoint not to exceed two experienced men as inspectors of natural gas pipes to do said work.

## SPECIFICATIONS

For the conduits and conductors to be used by C. C. Perry, for the under-ground transmission of the electric current for electric lighting, and for other purposes, in the City of Indianapolis.

**CONDUITS.**—The conduits for the protection of the conductors, are to be constructed of lumber, the several parts being proportioned and secured substantially as shown in the accompanying drawing; or they may consist of iron tubes lined with concrete, or of tubes of indurated fibre, with the cables drawn through and laid in conformity with Ordinance No. 44, 1888.

**CONDUCTORS.**—The main line conductors are to be cables containing 133 No. 13 copper wires, more or less, the wires being protected by a suitable water-proof insulation. Branch cables are to be of ample size to transmit the required quantity of current without any dangerous increase of temperature.

**INSULATION.**—In addition to the insulation provided in the manufacture of the cables, they are also to be insulated from the conduit boxes by bearings of baked wood saturated with paraffine wax. These bearings are to be placed from three to five feet apart, the distance being so close as to prevent the cables from touching the conduit boxes, either at the bottom or sides. After the cables are thus secured in a central position, the conduit boxes are to be filled with melted pitch, which will exclude moisture and air, and will form a complete insulation of the cables.

His Honor, the Mayor, appointed Councilmen Trusler, Gaul and Finch to act as members of such Committee on the part of the Common Council.

As follows: Strike out the words and figures “within 60 days,” and insert in lieu thereof the following words: “Within the time now provided by law and the ordinances of the city.” Also, by striking out the words “as any tax for street improvements would be collected,” and insert the following words: “as provided by law and the ordinances of the city.”

*Gentlemen.*—The undersigned, owner of real estate fronting on north Pennsylvania street, between Seventh street and Exposition avenue, respectfully remonstrates against the passage of a declaratory resolution providing for the improvement of the roadway of Pennsylvania street, from Seventh street to Exposition avenue, by curbing with stone the outer edges thereof (where not already properly curbed,) and paving the roadway with asphaltic sheet pavement.

*Resolved,* That as owners of real estate on north Pennsylvania street, between Seventh street and Exposition avenue, in the City of Indianapolis, we are opposed to the improvement of said street in the manner set forth in the foregoing notice, for the reasons following, to-wit:

1st. We have at great expense to ourselves, just put in for most of the distance mentioned in said notice, good curb stones and bowldered the gutters, and have put said street in most excellent condition, and hence there is no occasion for said contemplated improvement.

2d. No sewer has been constructed in said street, nor have the gas and water mains—such as eventually will be necessary to be put in said street—been laid; and if said improvement is made, it can not and will not be permanent; but, on the contrary, of necessity will in a short time have to be torn up and the street spoiled, to the great damage of the property owners.

3d. We are of the opinion that a good gravel street, such as we now have, is the best street, and certainly the cheapest, and that it is more easily kept in repair. In other words, we have just such a street as we want, and we are decidedly opposed to tearing it up so soon after its construction and putting down another, which, in our judgment, is no better than the one we already have.

4th. Most of those who own property on said street, are not able to incur the expense of making said contemplated improvement.

5th. Because as yet much of said property has not been improved, and when improved, it will be necessary to make gas and water connections, and thus the street will be necessarily broken up and spoiled.

6th. Because less than two-thirds in number of feet fronting upon said street, have petitioned for said improvement.

7th. Because no profile and specifications of said contemplated improvement have been filed in the office of the City Engineer of said city, as is stated in said notice.

*It was further Resolved,* That this minute shall be filed with the City Clerk of said city, and that William H. Talbott, Thomas H. Sharpe, Francis M. Abbott and William Watson Woollen be appointed a committee to present it to the Common Council and Board of Aldermen of said city. On motion, said meeting adjourned.




