# COMMON COUNCIL.

REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS,
Monday, August 19th, 1867, 2 o'clock, P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Burgess, Coburn, Colley, Cottrell, Davis, Geisel, Henschen, Jameson, Kappes, Loomis, MacArthur, Seidensticker and Woodburn—14.

Absent—Councilmen Goddard, Schmidt and Stanton—3.

The proceedings of the regular session held August 12, 1867, and of the adjourned sessions held August 15th and 16th, 1867, were read and approved.

His Honor, the Mayor, announced that the special order of business for the meeting was the consideration of the vacation of Biddle street.

Mr. MacArthur, from the Select Committee, made the following report:

Indianapolis, August 19, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—Your special committee appointed to visit Biddle street and vicinity, beg leave to make the following report:

That after having visited the premises in question we find, in our opinion,

that by the vacation asked for, in the present condition of the street and alley, the property holders are not inconvenienced at all by the proposed vacation, and it will be a great benefit to the Bellefontaine Railway Company in protecting their property. We therefore recommend that Biddle street and the first alley south of the same be vacated, as asked for by the Bellefontaine Railway Company.

Mr. Brown presented the following communication:

Office of the Bellefontaine Railway Co., Indianapolis, Aug. 17, A. D., 1867.

The Bellefontaine Railway Company being the owner in fee simple of lots Nos. 16, 17, 18, 19, 20, 21, 22 and 23, in Biddle's sub-division of a part of outlot No. forty-five (45), and tnat portion of said outlot immediately south of that part of Biddle's addition above described—the entire property immediately adjoining that part of Biddle street lying between lots Nos. 16, 17, 18, and lots Nos. 19, 20 and 21, and that portion of the alley south of said sub-division, between lots Nos. 19, 20 and 21, and the southern part of outlot No. 45, thereby consent to the vacation of that part of the street and alley above described and sought to be vacated by the Bellefontaine Railway Co.

Indianapolis, Ind., July 31, 1867.

To the Mayor and Common Council of the City of Indianapolis:

The undersigned, owners of property fronting on Biddle street, in the City of Indianapolis, after carefully considering the question of vacation as proposed in the petition of the Bellefontaine Railway Company, now before the Council, hereby consent to such vacation for the reasons stated in said petition.

Edward King, owning lot 5, fronting 150 feet on Biddle street. Bellefontaine R. W. Co., per Edw. King, Sec., owning lot 23, fronting 40

feet on Biddle street.

Bellefontaine R. W. Co., per Edw. King, Sec., owning lot 22, fronting 40 feet on Biddle street.

James Breen, owning lot 6, fronting 150 feet on Biddle street. In all 380 feet.

The entire frontage on both sides of Biddle street, excepting that part proposed to be vacated, is only 700 feet, of which 380 feet consent, as above, to the vacation, it being 30 feet over half of the entire frontage on both sides of that portion of Biddle street not proposed to be vacated.

Which was received.

On motion by Mr. Brown, the vote was taken on vacation.

The question being, shall the vacation be ordered? those who voted in the affirmative were Councilmen Brown, Burgess, Cottrell, Davis, Henschen, Loomis, MacArthur and Woodburn—8.

Those who voted in the negative were Councilmen Coburn, Geisel and Seidensticker—3.

Councilmen Colley, Jameson and Kappes present but not voting.

Mr. MacArthur offered the following resolution:

Resolved, That until the legal question is settled as to the power of the Council to make the vacation asked for by the Bellefontaine Railway Company in Biddle's sub-division, said Company be, and is hereby, permitted to build and maintain a fence across Biddle street at the point designated for vacation in their petition now before the Council, and across the first alley south of said street, on the western line of their lots, in said Biddle's subdivision.

Mr. Geisel moved to lay the resolution on the table, and called for the ayes and noes.

The question being on laying the resolution on the table, those who voted in the affirmative were Councilmen Coburn, Colley, Geisel and Seidensticker—4.

Those who voted in the negative were Councilmen, Brown Burgess, Cottrell, Davis, Henschen, Loomis, MacArthur, and Woodburn—8.

So the motion to lay on the table was not adopted.

The question then being on the passage of the resolution, those who voted in the affirmative were Councilmen Brown, Burgess, Cottrell, Davis, Henschen, Loomis, MacArthur and Woodburn—8.

Those who voted in the negative were Councilmen Coburn, Colley, Geisel and Seidensticker—4.

So the resolution was adopted.

Mr. Brown offered the following motion:

That the Street Commissioner be directed to build wooden culverts over the gutters on both sides of Meridian street at the crossing of Maryland st., and, also, over the gutters on said street where the alley running east and west through squares 74 and 75 crosses said Meridian street.

Which was adopted.

Mr. Coburn presented the following communication:

INDIANAPOLIS, Aug. 19, 1867.

To the Mayor and Common Council of the City of Indianapolis:

I will manufacture for said City of Indianapolis one of Silsby's First Class Rotary Steam Fire Engines within about 60 days from date of acceptance of this proposal by said Council. I agree that said engine shall be built of the best materials and in the most workmanlike manner, with all our recent improvements, including copper tubes and flues, and brass jacket for boiler, and will warrant the same to work in a satisfactory manner. I will also put in thorough repair steam engine No. 3, now owned by the city, at such time as the Chief Engineer of the Fire Department shall designate. In order that there shall be no misunderstanding as to what is meant by "thorough repair of the old engine," I would respectfully suggest that when the engine is sent on for repairs, the engineer of the machine be sent with it, to super.ntend and to direct what repairs shall be made, and I hereby agree that whatever he declares on his judgment is necessary to be done shall be done.

In full payment for the new engine and for the repairs on the old engine

the City of Indianapolis shall pay to H. C. Silsby the sum of six thousand dollars, in current funds, at the time of the delivery of the new engine, the R. BICKFORD, city paying freight.

Mr. MacArthur moved to refer the communication to the Fire Committee.

Mr. Coburn moved to amend by receiving the communication and proposition, and that the Chief Fire Engineer be instructed to make a contract on the terms proposed.

Mr. Davis moved to amend Mr. Coburn's amendment by deferring the matter until the Committee on Fire Department could correspond with the Amoskeag and others.

After long discussion, Mr. Burgess called for the previous question, which was sustained.

The vote was then taken upon Mr. Davis' amendment to Mr. Coburn's amendment.

The ayes and noes being called for, those who voted in the affirmative were Councilmen Colley, Davis, Kappes and Seidensticker-4.

Those who voted in the negative were Councilmen Brown, Burgess, Coburn, Cottrell, Geisel, Henschen, Jameson, Loomis, MacArthur and Woodburn-10.

So the amendment of Mr. Davis was not adopted.

A division of Mr. Coburn's amendment was called for.

The vote was then taken upon the motion instructing the Chief Fire Engineer to make a contract on the terms proposed.

Which was adopted.

Then upon the question to receive the communication and spread it upon the minutes.

Which was adopted.

The vote was then taken upon the original motion as amended.

Which was adopted.

Mr. Cottrell offered the following resolution:

Resolved, That the appointment of Wm. W. Smith as Judge of elections for the Fifth Ward, heretofore made by the Common Council, be, and the same is hereby, rescinded, and that the Council now proceed to elect a judge to fill such vacancy.

The question being on the passage of the resolution, those who voted in the affirmative were were Councilmen Brown, Burgess, Cottrell, Davis, Geisel and Henschen—6.

Those who voted in the negative were Councilmen Coburn, Colley, Jameson, Kappes, Loomis, MacArthur, Seidensticker and Woodburn—8.

So the resolution was not adopted.

Mr. Cottrell introduced general ordinance No. 100, entitled:

An Ordinance prohibiting officers or agents of the City of Indianopolis from purchasing from any member of Common Council of the City of Indianapolis, any article of personal property for the use or in behalf of said city, and to repeal an ordinance entitled "An ordinance prohibiting officers or agents of the City of Indianapolis from purchasing from any city officer," ordained and established the 29th day of May, 1867,

Which was read the first time by its title.

Mr. Geisel presented the following petition:

Indianapolis, Aug. 19, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Your petitioners, residents of the City of Indianapolis, along and near the track of the Bellefontaine Railroad Company, within the city limits, would respectfully represent to your honorable body that the passenger trains which pass on said track are in the habit of running (within the city) at a speed far too great, whereby the lives of the children of your petitioners are greatly endangered.

Wherefore, they pray your honorable body that such action be taken in the premises as to stop the fast running of such trains within the city.

Mr. Geisel offered the following motion:

That the Marshal and the members of the Police Force are hereby instructed to enforce the ordinance regulating the running of locomotives, page 121, section first.

Which was adopted.

Mr. Geisel, also, offered the following motion:

That the Street Commissioner be, and is hereby instructed to notify Christian Wishmeyer to raise his track on North street, between Noble and Davidson streets, level with the street.

Which was adopted.

Dr. Jameson presented the following petition:

Indianapolis, Aug. 19, 1867.

To the Mayor and Common Council of the City of Indianapolis:

The lot owners on the line of the alley passing through square 68, in the First Ward, running from Walnut to St. Clair streets, would respectfully represent that the grade is so constructed as to cause the water collecting from most of the square to pass north to St. Clair street, instead of the proper course to Walnut street. This water can get no outlet, and will consequently flood near one-fourth of the said square and lie there to the serious injury not only of the immediate lot holders but endangering the health of the whole neighborhood.

Mr. Kappes introduced special ordinance No. 71-1867, entitled:

An Ordinance to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on St. Joseph street, between Delaware and Alabama streets,

Which was read the first time by its title.

Mr. Loomis presented the following petition:

Indianapolis, Aug. 12, 1867.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen:—I have the honor to petition that I be allowed to go to work on Tennessee street, as I nave now extra facilities for pushing the work through. I can now put the dirt on at a cost, to me, of 20 cents per yard, thus clearing 50 cents per yard on my contract, whereas, if I do no work on the street I am continually at a loss, as small contracts, such as digging cellars, &c., &c., will not pay, unless I have some place to throw the dirt. I trust that something will be done at once. Also, I have received two partial estimates for grading and graveling on said street and have not received the money due from the cityfor the crossings of the streets and alleys, there being due for all crossings between the north side of Garden street and the south side of McCarty street, I having worked according to the stake set by the late James Wood, Civil Engineer.

Mr. Loomis offered the following motion:

That the Citizens Street Railway Company be permitted to erect hay scales on Tennessee street near their stables.

The ayes and noes being called for, those who voted in the affirmative were Councilmen Brown, Burgess, Coburn, Colley, Hensehen, Jameson, Kappes, Loomis, Seidensticker and Woodburn—10.

Those who voted in the negative were Councilmen Cottrell, Davis, Geisel and MacArthur—4.

So the motion was adopted.

Mr. Loomis introduced special ordinance No. 72-1867, entitled:

An Ordinance to provide for lighting the line of the Union Railway track with gas between South East street, near Maryland street, and South Mississippi street, at the crossing on Louisiana street,

Which was read the first time by its title.

Mr. Loomis introduced special ordinance No. 73-1867, entitled:

An Ordinance to provide for grading and graveling Cady street from Harrison street to Bates street,

Which was read the first time by its title.

Mr. Loomis introduced special ordinance No. 74-1867, entitled:

An Ordinance to provide for grading the alley running north and south through the south half of out-lot No. 101, between Greer and Water sts., from McCarty street to the 20 foot alley on the line between the north and south half of said out-lot No. 101; and so much of the 20 foot alley on the line east and west, between the north half and south half of out-lot No. 101, as extends from the east side of the alley first above named, running west to the east side of Greer street and the alley running north and south

between lots Nos. 33 and 34, in the north half of said out-lot No. 101, to Stevens street,

Which was read the first time by its title.

Mr. Loomis introduced general ordinance No. 101-entitled:

An Ordinance creating the office of meat inspector in and for the City of Indianapolis, and defining his duties,

Which was read the first time by its title.

Mr. Loomis introduced general ordinance No. 102-entitled:

An Ordinance authorizing the Indianapolis and Vincennes Railroad Company to construct a track within and through the City of Indianapolis, prescribing the terms thereof,

Which was read the first time by its title.

Mr. MacArthur offered the following motion:

That MacArthur & Blake be granted the right to erect a hay scale in front of their premises, No. 15 South Delaware street.

The ayes and noes being demanded, those who voted in the affirmative were Councilmen Burgess, Colley, Geisel, Henschen and Jameson—5.

Those who voted in the negative were Councilmen Brown, Coburn, Cottrell, Davis, Kappes, Loomis. MacArthur, Stanton and Woodburn—9.

So the motion was not adopted.

Dr. Woodburn presented the following petition:

Indianapolis, Aug. 17, 1867

To the Mayor and Common Council of the City of Indianapolis:

The undersigned would respectfully call the attention of your honorable body to the fact that the north gutter of Vermont street, between Illinois and Tennessee streets, is at least two inches lower immediately in front of their residences, Nos. 82 and 84, than at its outlet at Tennessee street, and they earnestly request that you order it to be properly graded.

two feet on the outside of each rail prior to the contractor commencing work on such proposed improvement.

Which was adopted.

His Honor, the Mayor, presented the following communication:

Indianapolis, Aug. 19, 1867.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:-I have the honor to represent that the City Court Room is so meagerly supplied with seats that the Marshal is compelled to move the chairs and settees back and forth from the Council Chamber in order to accommodate the prisoners and witnesses in my Court. #### REPORTS FROM BOARDS.

Mr. MacArthur, from the Board of Public Improvements, made the following report:

> OFFICE BOARD OF PUBLIC IMPROVEMENTS, ) Indianapolis, Aug. 16, 1867.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: - The Board of Public Improvements would respectfully report to your honorable body that we have instructed the Street Commissioner to place new culverts at the intersection of Mississippi and Garden

streets. Also, to either raise the gutter or build a culvert at the intersection of Bluff Road and Ray street. Also, to raise the sidewalk on south side of Illinois street, at the crossing of Merrill and vicinity.

We have, also, examined the remonstrance of W. E. Featherstone and others in regard to the paying and curbing of the sidewalks on Washington street, between Mississippi and Missouri streets, and find that said improvement is very much needed; the sidewalks, where there is no pavement, is in a very bad condition. We therefore recommend that the prayer of the remonstrants be not granted, and that the City Auditor be instructed to advertise for proposals for said work.

Gentlemen: —The Board of Public Improvements to whom the bids were referred, would respectfully report that we find that Feary & Dillon are the lowest bidders for paving with brick the sidewalk of McNabb street, their bid being 70 cents per foot front.

Also, that Joseph Schwartzer is the lowest bidder for grading the alley between Liberty and Noble streets, at 4½ cents per lineal foot front on each

Uniform same as regular force, with silver cord down outer legs of pants, silver stripe around coat sleeve below elbow, and silver cord on cap above the lower band.

The following rules have, from time to time, been adopted by your Board for the government of the Police Force of the city. Under the ordinance lately passed by Council the "Merchants' Police" and the "Union Depot Police" are specially charged, as, also, the regular force, to faithfully carry out all the provisions, "Rules and Regulations for the general government of the Police Department of Indianapolis," and in addition thereto to observe the following:

When such Police appear on the street, or elsewhere, they shall be deemed (if in uniform as provided) to be on duty, and subject to all the rules applicable to the government of the Police of the city.

Any Policeman visiting any saloon, house of ill fame, beer garden, or any gaming house, or houses of bad repute, recognised as such, shall be forthwith discharged, and they shall not again be placed on said force during the ensuing year after such discharge: Provided, Should any one of such force deem it necessary to visit such places while discharging his official duties as such officer, then, in that case, this rule is not to apply, otherwise to remain in full force and virtue.

Members of Council and citizens knowing any policeman to violate any rules of the Council, ordinances thereof, or orders of the Police Board, are requested to furnish the Board with the correct data upon which to base a

removal from office of such offender.

For a more perfect government of the Police force of the city, your Board are constrained to ask Council for the privilege of preparing a condensed form of City Ordinances governing the police, and, also, of the orders of your Board, and that the same be printed and copies thereof furnished to the members of the Police for their government.

Your committee would recommend that the old bridges on said street be removed, one to the crossing of Mississippi street and Pogue's Run, and the other to the crossing of the Canal and South street; and that a new bridge be constructed on New Jersey street the full width of said street.
