The Common Council met in adjourned session.

Mr. Kahn presented the following resignation :

To the Mayor and Common Council of the City of Indianapolis :

That E. Culver be permitted to pave with brick, the sidewalk in front of his property, corner Indiana avenue and Ellen street, under the direction of the Civil Engineer.

Mr. Locke offered the following motion :

That two members be added to the Committee on Public Schools.

Mr. Marsee called for the ayes and noes on the adoption of the motion.

Those who voted in the affirmative were, Councilmen Brown, Cottrell, Harrison, Heckman, Kennington, Locke, Thalman, Thoms, Weaver, Whitsit, Wiles and Woodburn—12.

Those who voted in the negative were, Councilmen Kahn, Marsee, Newman, Pyle and Reagan—5.

Mr. Marsee offered the following motion :

That the Street Commissioner be directed to notify the Indianapolis, Peru and Chicago Railroad Company, to raise their tracks where they cross East street, up to the proper grade of the street, which the City Civil Engineer is hereby directed to give them immediately. Said work to be done within sixty days from this date.

Also the following motion :

That the Street Commissioner be directed to notify the Cleveland, Columbus, Cincinnati and Indianapolis Railway, to raise their tracks where they cross New Jersey, up to the proper grade of the street, which the City Civil Engineer is hereby directed to give them immediately. Said work to be done within sixty days from this date.

Mr. Newman offered the following motion :

That the Committee on Finance, Mayor, Treasurer and Clerk, be directed to meet at the office of the City Clerk, on Saturday, May 14, 1870, at 10 o'clock A. M., and destroy the city bonds, cancelled, now in the possession of the Clerk.

Also the following :

That the Citizens' Street Railway Company be required to lay the track and replace the boulders on North Pennsylvania street, between Ohio street and North street within ten days, or that the Street Commissioner fill up the excavation made by the Street Railway Company, and replace the boulders at the expense of the Street Railway Company, he notifying them at once what they are required to do.

Mr. Newman introduced General Ordinance No. 22, 1870, entitled :

AN ORDINANCE to provide for the compensation of City Officers, and Members of the Police Force and Fire Department, for the fiscal year ending May, 1871.

Which was read the first time.

Mr. Newman moved to suspend the rules for the purpose of reading the ordinance the second and third times and placing it upon its passage.

The question being on the suspension of the rules,

On motion by Mr. Brown, the Ordinance was referred to the Finance Committee; the City Clerk instructed to have copies printed for the information of the Council, and made the special order for Saturday, May 14, 1870, at 7½ o'clock P. M.

First.—The sidewalks having been once graded and graveled, are now in comparatively good condition.
