SPECIAL SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE }
CITY OF INDIANAPOLIS, }
FRIDAY DECEMBER 30, 1870, 7 O'CLOCK, P. M. }

The Common Council met in special session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members :

Councilmen Brown, Cottrell, Heckman, Kahn, Kennington, Marsee, Reagan, Shepherd, Thoms, Weaver, Whitsit and Woodburn—12.

Absent—Councilmen Harrison, Locke, Newman, Pyle, Thoman and Wiles—6.

Dr. Woodburn offered the following resolution :

Resolved, That all territory which has been platted and annexed to the city, and all contiguous territory annexed to the city by resolution of the Common Council with the consent of the Board of County Commissioners of Marion county, whether the order for such annexation be appealed from or not, and whether such appeal is decided or remains undetermined, be by the City Assessor entered on the tax list of the city.

Which was adopted by the following vote :

Affirmative—Councilmen Brown, Cottrell, Heckman, Kahn, Kennington, Marsee, Reagan, Shepherd, Thoms, Weaver, Whitsit and Woodburn—12.

Negative—None.

Dr. Woodburn called up Special Appropriation Ordinance No. 73, 1870, appropriating money for the payment of sundry claims against the city, which was read the second time and ordered to be engrossed.

By consent, the ordinance was then read the third time, and passed by the following vote :

Affirmative—Councilmen Brown, Cottrell, Heckman, Kahn, Kennington, Marsee, Reagan, Shepherd, Thoms, Weaver, Whitsit and Woodburn—12.

Negative—None.

Mr. Woodburn introduced Special Appropriation Ordinance No. 75, 1870, entitled :

An Ordinance appropriating money for the payment of sundry claims on account of the Station House, or City Prison.

Which was read the first time.

Mr. Weaver introduced Special Appropriation Ordinance No. 76, 1870, entitled :

An Ordinance appropriating money to aid in defraying the expense of building abutments for the new bridge over White River, at the west end of Washington street.

Which was read the first time.

By consent, the ordinance providing for the appraisement of real estate in the city of Indianapolis, for the year 1871, was read the second and third times, and passed by the following vote:

Affirmative—Councilmen Brown, Cottrell, Heckman, Kahn, Kennington, Marsee, Reagan, Shepherd, Thoms, Weaver, Whitsit and Woodburn—12.

Negative—None.

By consent, Mr. Brown introduced General Ordinance No. 73, 1870, entitled:

An Ordinance to amend an ordinance entitled, An Ordinance authorizing the issuing of 10 per centum two years city warrants for city sewerage purposes, ordained November 14, 1870.

Which was read the first time.

On motion, the Council adjourned.
