INTRODUCTION OF APPROPRIATION ORDINANCES

By the City Controller:

APPROPRIATION ORDINANCE No. 1, 1943

AN ORDINANCE appropriating Twenty-Four Hundred Dollars (\$2,400.00) from the anticipated, unappropriated and unexpended 1943 balance of the City General Fund and allocating the same to the Department of Public Safety budget, Fire Department, Fund 11—Salaries and Wages, Regular Auto Mechanic Lieutenants, and fixing the time when same shall take effect.

WHEREAS an error was made in the 1943 Department of Public Safety budget for the Fire Department in that it provides for only eleven (11) Auto Mechanic Lieutenants instead of twelve (12), there being twelve (12) such Lieutenants on the Fire Department payroll and necessary for the proper functioning thereof; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Twenty-Four Hundred (\$2,400.00) Dollars is hereby appropriated from the anticipated, unappropriated and unexpended 1943 balance of the City General Fund to the Department of Public Safety budget for the Fire Department, Fund No. 11—Salaries and Wages, Regular Auto Mechanic Lieutenants:

DEPARTMENT OF PUBLIC SAFETY

Fire Department

Fund No. 11—Auto Mechanic Lieutenants.....\$2,400.00

Section 2. That upon passage of this ordinance, the sum so hereby appropriated shall relate back to and be made available as of January 1, 1943.

Section 3. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Finance.

INTRODUCTION OF RESOLUTIONS

RESOLUTION No. 1, 1943.

WHEREAS, due to the national emergency that exists in our country today, there is a decided increase in the cost of living; and,

WHEREAS, the salaries of policemen and firemen have not been increased in proportion with the salaries of other workers, and,


WHEREAS, the duties of policemen and firemen are as important in the defense of our country as the men actively engaged in the manufacture of war materials;

THEREFORE, BE IT RESOLVED by the Common Council of the City of Indianapolis, Indiana, that this body go on record as favoring legislation increasing the minimum compensation to be paid the policemen and firemen of the City of Indianapolis.
