The Common Council met in regular session.

The proceedings of the regular session held July 13th, 1868, were
read and approved.

Business was resumed in the order in which it was left off at the
last regular meeting, viz:

ORDINANCES ON SECOND READING.

On motion by Mr. Henschen, special ordinances No. 47 and 48—1868, were taken up, read the second time and ordered to be engrossed.

On motion by Mr. Kappes, special appropriation ordinance No. 35—1868, was taken up, read the second time, and ordered to be engrossed.

On motion by Mr. Geisel, special ordinance No. 59—1868, was taken up, read the second time, and ordered to be engrossed.

ORDINANCES ON THIRD READING.

Dr. Woodburn called up special ordinance No. 42—1868, entitled :
AN ORDINANCE to provide for grading and graveling Muskingum street, between Vermont and New York streets, including the sidewalks.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were, Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis MacArthur, Schmidt, Seidensticker and Woodburn—13.

No Councilman voting in the negative.

So the ordinance passed.

Dr. Woodburn called up special ordinance No. 53—1868, entitled :
AN ORDINANCE to provide for grading and graveling Paoki alley running north and south through Square 6, between Michigan and North streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—13.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Seidensticker called up general ordinance No. 154—1868, entitled :

AN ORDINANCE to prevent the firing of cannons, &c.

Dr. Jameson moved to reconsider the vote ordering the engrossment of the ordinance.

The question being on reconsideration, those who voted in the affirmative were, Councilman Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—13.

No Councilman voting in the negative.

So the motion to reconsider was adopted.

Mr. Seidensticker moved to insert after the words "unlawful to fire" the words "or in any manner assist in firing."

Which was adopted.

Mr. Loomis offered the following amendment to section 1.

Provided, However, that cannon may be fired in the Court House and State House squares.

Which was lost.

Mr. Davis offered the following, to be inserted immediately after the word cannon.

Or any other instrument producing the same effect.

Which was adopted.

A motion by Mr. Loomis to postpone the ordinance indefinitely, was lost.

On motion the ordinance was then ordered to be engrossed.

The ordinance was then read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were, Councilman Brown, Davis, Geisel, Henschen, Jameson, Kappes, MacArthur, Schmidt and Seidensticker—10.

Those who voted in the negative were, Councilmen Foster and Loomis—2.

So the ordinance passed.

Mr. Geisel called up special ordinance No. 56—1868, entitled :

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on Chatham street, between St. Clair street and Massachusetts Avenue.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—13.

No Councilman voting in the negative.

So the ordinance passed.

By unanimous consent Mr. MacArthur presented the following petition :

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—We, the undersigned, property holders on Mississippi street, respectfully petition your honorable body to open the gutter on the north side of Market street, from Mississippi street west to the Central Canal, and also remove the obstructions placed on the sidewalks between the points named, consisting of hay scales and an office for business purposes. On Thursday evening last after the heavy rain on that day, some of us were compelled to wade knee deep in water to get to our homes. It also filled our cellars with water in some instances, and during the heavy rain at one time last spring it actually filled the basement story of a house owned by Mr. Trumbull G. Palmer, and at that time occupied by Joshua Staples, Sr., to a depth of two or three feet. The cause of so much water standing and collecting there is because Illinois street on the west side is drained down Market street to the Canal, and the culvert crossing Market street at the intersection of Mississippi street is too small to pass the water through, and consequently dams it back on us, and does us so much injury. Hoping that you will take some action at once, and prevent any more injury to our property, we remain,

Which was referred to the Board of Public Improvements.

Mt. MacArthur offered the following motion :

That the Board of Public Improvements be instructed to report on the Ordinance to grade and gravel the east sidewalk of Ellen street, between Indiana Avenue and North street.

Which was adopted.

Mr. MacArthur asked and obtained leave of absence for the remainder of the evening.

Mr. Seidensticker called up special ordinance No. 40—1868, entitled :

AN ORDINANCE to provide for the grading and graveling of Ohio street, between Davidson street and Harvey street (Corporation line.)

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilman Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

Dr. Woodburn called up special ordinance No. 52—1868,—entitled:

AN ORDINANCE to provide for the erection of lamp-posts, lamps and fixtures complete to burn gas, except the service pipe, on St Clair street, between Meridian and Illinois streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilman Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Kappes called up special appropriation ordinance No. 35—1868, entitled.

AN ORDINANCE appropriating moneys for the payment of sundry claims on account of the City Hospital for the month of June, 1868.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Seidensticker called up general ordinance No. 141—1868, entitled:

AN ORDINANCE regarding nuisances.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, God-

dard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Geisel called up special ordinance No. 20—1868, entitled.

AN ORDINANCE to provide for grading and graveling Ash street and sidewalks between Massachusetts Avenue and the corporation line.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Henschen called up special ordinance No. 47—1868, entitled :

AN ORDINANCE to provide for grading and graveling Dougherty street and sidewalks between East and Wright streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were, Councilman Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilmen voting in the negative.

So the ordinance passed.

Mr. Henschen called up special ordinance No. 48—1868, entitled :

AN ORDINANCE to provide for grading and graveling Coburn street and sidewalks between East and Wright streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Seidensticker called up general ordinance No. 152—1868, entitled :

AN ORDINANCE relative to trespass on houses.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen, Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the ordinance passed.

UNFINISHED BUSINESS.

Mr. Loomis moved to re-consider the vote by which an ordinance entitled : "An ordinance granting a license to Mark L. Hare" was ordered to be stricken from the files.

Mr. Seidensticker called for the ayes and noes.

Those who voted in the affirmative were, Councilmen Foster, Loomis, and Woodburn—3.

Those who voted in the negative were Councilmen Brown, Davis, Geisel, Goddard, Henschen, Jameson, Kappes, Schmidt and Seidensticker—9.

So the motion to reconsider, was not adopted.

REGULAR ORDER OF BUSINESS.

Mr. Brown presented the following communication :

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis :

We, the undersigned, do certify that we have examined the steam fire engine boiler, built by A. S. Foster, at the Eagle Machine Works, and have seen it tested with the following result: In one minute and thirty-three seconds (1:33) from the time the fire was applied until the guage showed steam, and in four minutes commenced working an engine with twenty (20) pounds of steam, and it continued to increase steam in ten minutes to one hundred and ten (110) pounds, whilst running the engine and pumping cold water into the boiler.

We consider it the best boiler for steam fire engines in use.

Which was referred to the Committee on Fire Department and Chief Fire Engineer.

Mr. Brown offered the following motion :

That Thomas M. Chill and other residents of Chestnut street be allowed the privilege of cutting a small ditch in said street for the purpose of draining a pond in said street into the McCarty Lake Ditch, provided the same be done at their own expense, and to the satisfaction of the City Civil Engineer.

Which was adopted.

Mr. Brown offered the following motion :

That the Street Commissioner be required to immediately construct a wooden culvert with stone foundations, across Meridian street on the north side of South street.

Which was referred to the Board of Public Improvements with instructions to have the work done if necessary.

Mr. Brown offered the following motion :

That Charles Schwomeyer be allowed the privilege of removing his hay scales from Russell street to the east side of Meridian street, in front of his grocery store, at the corner of McCarty street, provided that the said scales be placed on a level with the grade of the street, and so as not to interfere with the gutters.

Which was adopted.

Also the following motion :

That the Street Commissioner be directed to change the location of the wooden culvert across Chestnut street, south of Madison Avenue, so as to place the same on the south-west side of Madison Avenue.

Which was adopted.

Also the following motion :

That the Street Commissioner be instructed to notify the Jeffersonville, Madison and Indianapolis Railroad Company to change the width of the culvert under the Madison Railroad track, near the crossing of Madison Avenue, so that the same shall be six feet in width.

Which was adopted.

Mr. Brown offered the following motion :

That the Street Commissioner be instructed to construct a wooden culvert with stone foundations, across Washington street, on the east side of Pennsylvania street, so as to connect the gutters on the north side of Washington street with those on the south of said street.

In reference to which Mr. Seidensticker offered the following motion :

To refer to Board with instructions to also report as to the necessity of building another culvert at New Jersey and Washington streets and Illinois and Washington streets.

Which was adopted.

Mr. Brown offered the following motion :

That a stone street crossing be placed on the south-west side of Virginia Avenue from the west line of Pennsylvania street to the east line of said street, and that the same be done by the Street Commissioner.

Which was referred to the Board of Public Improvements.

Mr. Brown offered the following motion :

That the Street Commissioner be and is hereby directed to remove a dead tree standing on South Illinois street, near the Palmer House.

Which was adopted.

Mr. Davis offered the following motion :

That the Civil Engineer be directed to report the amount retained and yet due to Kruger & Roney for building cisterns at the corner of Walnut and Tennessee streets, and at the corner of East and Gregg streets, provided said cisterns are now in perfect order, and that the Chief Fire Engineer be directed to report the condition of said cisterns to this Council.

Which was adopted.

Mr. Foster offered the following motion :

That the Civil Engineer be instructed to furnish the Street Commissioner with a plan for a bridge across the canal at Merrill street with such specifications that the cost will not exceed \$650.

The Street Commissioner is hereby directed to build the above bridge.

Which was referred to the Committee on Bridges.

Mr. Geisel offered the following resolution :

Resolved, That the matter of the opening of Plum street be referred back to the Commissioners, and that they be requested to take proper action therein, and report the same to this body.

Resolved, That the Marshal give said Commissioners due notice of these resolutions.

The question being on the adoption of the resolution, those who voted in the affirmative were, Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the resolution was adopted.

Mr. Geisel offered the following motion :

That H. K. Martz be and is hereby permitted to pave the sidewalk in front of his property, 189 North Noble Street, nine feet wide, under the direction of the Civil Engineer, within thirty days.

Which was adopted.

Mr. Geisel introduced general ordinance No. 156—1868, entitled :

AN ORDINANCE to repeal an ordinance entitled, "An ordinance creating the office of Gas Inspector, defining his duties and fixing his salary."

Which was read the first time.

Mr. Goddard presented the following petition :

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis :

The undersigned would respectfully represent that there is a low place in West street at the crossing of Georgia street, and that when it rains the water runs over the sidewalk and fills her lot and the first floor of a part of her house, greatly to her injury and inconvenience. She would therefore respectfully ask that a small culvert be made across West street so as to throw the water into its natural channel on the low grounds west of West street. There was a temporary culvert at this point but it is now worn out.

Dr. Jameson presented the following petition :

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis :

We, the undersigned, property holders of that part of the city on and adjacent to New Jersey street, between New York and Washington streets, beg leave to represent to your honorable body that owing to the surface water of all the streets between Pennsylvania and Liberty streets being thrown on our street, the whole of said street and many parts of the sidewalks are flooded and submerged with each rain, many of our cellars and lots are filled with water, and the streets made impassable, and our property is thereby greatly injured. We therefore pray your honorable body for the drainage of said street at as early a time as practicable, by the erection of a sewer on the same, and as in duty bound we will ever pray, &c.

GENTLEMEN:—We, the undersigned, beg leave to request of your honorable body that such steps will be taken as will drain off the surface water from that part of the city adjacent to the crossing of North New Jersey and St. Clair streets. There is a large basin in this vicinity embracing five or six squares, from which, as now graded, the water cannot flow away. We are of the opinion there is no way in which this evil can be removed except by proper sewerage. We therefore pray your honorable body to provide for the same as speedily as practicable.

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—In a report made to the Council several weeks ago in regard to the location of East, Jackson, Broadway and Plum streets, we recommended that these streets at their intersection with St. Clair street and Massachusetts Avenue be located at the distances from New Jersey street given on the recorded plots of the sub-divisions of out-lots 178 and 181. There is about one foot of surplus ground between New Jersey street and Massachusetts Avenue. At that time we thought it best to leave this surplus on the east of Plum street, but subsequent surveys have satisfied us that it would be better to place it in the first alley west of Plum street.

We would therefore ask the Council for permission to change our report.

Mr. Kappes presented the following petition :

INDIANAPOLIS, July 20, 1868.

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—Your petitioner, Christian Schloer, respectfully represents to your honorable body that he is a resident citizen of Indianapolis, and the owner of lots 25 and 26, said lots running north and south from the National Road to Washington street immediately east of the White River bridge, and run to the water line of White River. Your petitioner would further represent that the location of said two lots are eminently fit, and of the best possible location for an extensive City Bath Institute. That such institutes are

used and kept up in other larger cities like Cincinnati, Boston, New York, etc. That bathing in the river is a great desideratum in this city for the health and comfort of all citizens—far preferable to a bath house bathing—and would be pecuniarily more accessible to all classes of the community. Your petitioner would further represent that the building and fitting up of such a bathing institute, according to and in conformity with the city ordinances, and such other rules and prescriptions as your honorable body might deem proper, will cost your petitioner not less than fifteen hundred dollars. Your petitioner in view of the premises, therefore prays your honorable body to grant him the right and privilege to erect, and maintain, and use the ground immediately south of said lots, and so much of the river bed as would be necessary to erect such a building or buildings for bathing purposes, for and during the time that such building or buildings are kept up and used for the aforesaid purpose, and that your honorable body pass an ordinance for the occupancy, and the protection, use and possession of the ground immediately between the property of your petitioner aforesaid and the part of the river necessary for the erection and maintaining of such building or buildings.

So the resolution was adopted.

Also the following resolution :

Resolved, That the foregoing first and final estimate allowed James Stewart for grading and graveling Plum street and sidewalks, between Massachusetts Avenue and Cherry street, be and the same is hereby adopted as the estimate of this Council, and that the property owners are hereby required to pay the sums set opposite their respective names.

The question being on the adoption of the resolution, those who voted in the affirmative were Councilmen, Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.

So the resolution was adopted.

Also the following resolution :

Resolved, That the foregoing first and final estimate allowed John Feary and Thomas Dillon for grading and paving the west sidewalk on Illinois street, between North and First streets, be and the same is hereby adopted

as the estimate of this Council, and that the property owners are hereby required to pay the sums set opposite their respective names.

The question being on the adoption of the resolution, those who voted in the affirmative were Councilmen Brown, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Schmidt, Seidensticker and Woodburn—12.

No Councilman voting in the negative.
