INTRODUCTION OF PROPOSALS

PROPOSAL NO. 289, 1974. Introduced by Councilman Gorham. PROPOSAL NO. 290, 1974. Introduced by Councilman Cottingham. The Clerk read the proposal entitled: "A proposal for a Fiscal Ordinance amending the CITY-COUNTY ANNUAL BUDGET FOR 1974 and appropriating the sum of Fifty-nine thousand five hundred dollars (\$59,500.00) for certain purposes of the County Jail by reducing certain other appropriations for that department;" and the President referred it to the County and Townships Committee.

Upon motion made by Councilman Boyd, seconded by Councilman Gorham, the meeting adjourned at 9:20 P.M.


