In Judge Dugan's case, there are two court reporters that he wishes to pay at the same level because they are performing equivalent jobs. He added that the two positions were paid the same amount in prior years and this proposal increases the salary of the one court reporter in question. Councillor Rhodes moved to amend Proposal No. 40, 1981, by deleting the line of Assistant Court Reporter and amending the line of Court Reporter from (1) to (2) at a salary of \$16,425. Councillor Rhodes' amendment failed on the following roll call vote; viz:

She said that the Assistant Court Reporter's maximum salary for 1980, per Fiscal Ordinance No. 106, 1979, which was not amended, was \$14,500, and apparently Judge Dugan paid his employee \$15,000, the same salary as the other Court Reporter. Councillor Nickell stated that the Assistant Court Reporter's approved maximum was \$14,500 in 1980. This amount plus the 9.5% increase authorized by the Council, would elevate the maximum salary for this person to \$15,878. This should be the maximum salary paid for this position, which is still \$2,000 to \$3,000 more than the other courts. This same position is classified as an Administrative Assistant in five of the other six Civil Courts with the maximum salary ranging from \$12,483 to \$14,500. She also noted that when this Court's budget was presented to the Committee, the maximum salary requested was \$15,013 and the Judge now wishes to increase this to \$16,426. Councillor Nickell then moved to amend Proposal No. 40, 1981, making the maximum salary per classification \$15,878 and Temporary Salary \$3,315, seconded by Councillor West. Councillor Rhodes injected another amendment by deleting the line for the Assistant Court Reporter, seconded by Councillor Journey. Councillor Howard then moved to "Table" the amendment to Proposal No. 40, 1981, allowing Judge Dugan to be present, seconded by Councillor Page. The President then called

Proposal Nos. 99 and 101, 1981, were retitled GENERAL ORDINANCE NO. 26, 1981, and GENERAL ORDINANCE NO. 27, 1981, respectively, and read as follows:

CITY—COUNTY GENERAL ORDINANCE NO. 26, 1981

A GENERAL ORDINANCE establishing one-way southbound traffic on Greer Street between McCarty Street and Buchanan Street. (Amends Code Sec. 29-166)

**BE IT ORDAINED BY THE CITY—COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:**

SECTION 1. The "Code of Indianapolis and Marion County, Indiana", specifically, Chapter 29, Section 29-166, "One-way streets and alleys designated", be, and the same is hereby amended by the addition of the following, to wit:

SOUTHBOUND

Greer Street, from McCarty Street to Buchanan Street.

SECTION 2. This ordinance shall be in full force and effect upon adoption and compliance with IC 18-4-5-2.

CITY—COUNTY GENERAL ORDINANCE NO. 27, 1981

A GENERAL ORDINANCE establishing a load limit on Lesley Avenue between 30th Street and Massachusetts Avenue. (Amends Code Sec. 29-224)

**BE IT ORDAINED BY THE CITY—COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:**

SECTION 1. Chapter 29 of the "Code of Indianapolis and Marion County, Indiana", specifically Section 29-224, "Trucks on certain streets restricted", be, and the same is hereby amended by the addition of the following, to wit:

11,000 POUNDS GROSS WEIGHT

Lesley Avenue, from Thirtieth Street to Massachusetts Avenue

SECTION 2. This ordinance shall be in full force and effect upon adoption and compliance with IC 18-4-5-2.

PROPOSAL NO. 103, 1981. Introduced by Councillor SerVaas. This proposal, which declares the expansion of the Marion County Jail as a necessity and authorizes construction through the Marion County Building Authority, received a "do pass" recommendation from the Public Safety and Criminal Justice Committee by a vote of 6-0. Councillor West moved, seconded by Councillor Tintera, to send Proposal No. 103, 1981, back to Committee to be discussed with Proposal No. 111, 1981. Consent was given. Councillor Page requested that a presentation be given to the Democrat Caucus by Archonics regarding the Jail Study.

PROPOSAL NO. 554, 1980. Councillor West stated that this proposal, which adds a Section 8½-88, restricting CATV operators from entering the private security market, received a "do pass as amended" recommendation. Councillor Rhodes stated that this would eliminate unfair competition. Councillor Rhodes then moved the amended version. Council consent was given by voice vote. Councillor Durnil expressed his concerns that this ordinance would create a monopoly. Councillor Brinkman noted that this proposal was introduced earlier, and at that time the cable companies did not have a problem with the ordinance. The President called for the vote, and Proposal No. 554, 1980, As Amended, was adopted on the following roll call vote; viz:

Proposal No. 554, 1980, As Amended, was retitled GENERAL ORDINANCE NO. 28, 1981, and reads as follows:

CITY-COUNTY GENERAL ORDINANCE NO. 28, 1981

A GENERAL ORDINANCE adding a provision to Article VI, Chapter 8 1/2, relating to private security.

BE IT ORDAINED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. The "Code of Indianapolis and Marion County, Indiana", be, and the same is hereby amended, by adding a new Section 8 1/2-88, as follows:

"Section 8 1/2-88. PRIVATE SECURITY.

The Operator or an affiliate of the Operator shall not engage in the private security business in Marion County, either directly or indirectly, except to the extent that communications lines are leased or made available to third parties for that purpose. An 'affiliate' for the purpose of this section, is any corporation or other business entity or association of which 50% or greater equity interest is owned or controlled by the Operator. Any corporation or business entity of which the Operator maintains an equity interest shall be subject to the same rate structure as charged by the Operator to other third parties for the lease or availability of lines for the providing of private security service."

PROPOSAL NO. 125, 1981. Introduced by Councillor Dowden under Presentation of Petitions, Memorials, Special Resolutions and Council Resolutions, this proposal endorses the concept of House Bill 1134. Councillor Dowden moved, seconded by Councillor Brinkman, for adoption. Proposal No. 125, 1981, was adopted on a voice vote, retitled SPECIAL RESOLUTION NO. 26, 1981, and reads as follows:

CITY—COUNTY SPECIAL RESOLUTION NO. 26, 1981

A SPECIAL RESOLUTION endorsing legislation which would return authority over salary ranges for county welfare employees to appropriate local legislative bodies.

WHEREAS, In September 1980, members of the Council's Community Affairs Committee declared their intention to support efforts by the 1981 General Assembly to revise State law in order to arrive at an alternative method of setting the salaries of County Welfare Employees that is acceptable to all parties; and,

WHEREAS, Measures are currently before the General Assembly which would offer a practical and stable alternative to the current system; now, therefore:

**BE IT RESOLVED BY THE CITY—COUNTY COUNCIL OF THE
CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:**

SECTION 1. The City-County Council hereby expresses its support of legislative measures to return authority over establishment of salary ranges for county welfare employees to appropriate local legislative bodies.

SECTION 2. The Mayor is invited to join in this resolution by affixing his signature hereto.

SECTION 3. This ordinance shall be in full force and effect from and after its adoption and compliance with IC 18-4-5-2.

NEW BUSINESS

Councillor Schneider requested the report concerning the status of the excessive levies and alternative plans to be taken. Mr. Fred Armstrong, City Controller, stated that there was a plan as it relates to the City. He noted that the State Board of Tax Commissioners certified rates which did not include the excessive levies for the Police and Fire Departments or any of the Cumulative Funds. He added that there

is \$2,300,000 not funded and the Director of Public Safety has agreed to find revenues or reduce expenditures in the amount of \$1,200,000. Mr. Armstrong stated that the Public Safety Department will be coming back to the Council with an ordinance to correct the funding problem.

ANNOUNCEMENTS AND ADJOURNMENT

There being no further business, and upon motion duly made and seconded, the meeting adjourned at 9:23 p.m.


