*FISCAL ORDINANCE NO. 2, 1975*, creating the annual budget of the Fire Special Service District of the City of Indianapolis, Indiana, for the fiscal year beginning January 1, 1976, and ending December 31, 1976, appropriating monies for the purpose of defraying the expenses and all outstanding claims and obligations of said Fire District and the Fire Pension Fund and fixing and establishing the annual rate of taxation and tax levy for the year 1976, for each fund for which a special tax levy is authorized and fixing a time when this ordinance shall take effect.

referred it to the Public Safety and Criminal Justice Committee.


Upon motion duly made, and by consent of Council members, all remaining Agenda Items were dispensed with.
