Dear Mr. Raub:

I want to avail myself of this opportunity of commending the work of the Indianapolis City Council in reviewing and amending the civil city budget of 1936. The careful study which they gave to it is an example of extraordinary and conscientious devotion to public interests. The budget as submitted to them seemed to allow little opportunity for safe reduction, but the thorough analysis of it by members of the council, who met night after night for consideration of it, calling in departmental heads and insisting that they explain the reasons not only for proposed increases but for all items, indicated great care in their efforts to serve the interests of taxpayers. The reduction of three cents in the levy for governmental operations is a very substantial saving, in view of the confidence of officials that they had reduced budget proposals to the minimum for safety. The fact that the budget as adopted by the Council now permits an adequate appropriation for track elevation, is of great importance to the City of Indianapolis, where more track elevation is so essential and can be at this time obtained advantageously with federal aid.

Personally, and as chairman of the Civic Affairs Committee of the Indianapolis Chamber of Commerce, I want you to know that your work on the budget is profoundly appreciated. I feel that the service you have rendered to the public deserves hearty commendation.

AN ORDINANCE authorizing the Board of Public Works and Sanitation, through its duly authorized purchasing agent to receive bids for the purchase of one (1) traction-trailer power unit for hauling garbage and ash trailers, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Works and Sanitation, by and through the Department of Public Purchase, its lawful agent, be and it is hereby authorized to receive bids, after advertising for competitive bids thereon, for the purchase of one (1) traction-trailer power unit for the garbage and ash collection department of the City of Indianapolis, used and to be used on the streets, alleys and thoroughfares of the City of Indianapolis.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

GENERAL ORDINANCE NO. 75, 1935

AN ORDINANCE amending General Ordinance No. 61, 1935, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 1 of General Ordinance No. 61, 1935, be and the same is hereby amended to read as follows:

Section 1. That the use of the following named streets of the City of Indianapolis is hereby prohibited for all automobiles weighing over one (1) ton, excepting passenger cars or motor buses devoted to the carriage of passengers for hire, to-wit:

- (a) Thirty-eighth Street, from Northwestern Avenue to Keystone Avenue.
- (b) Washington Boulevard, from Fall Creek Parkway, North Drive, to Westfield Boulevard.
- (c) Illinois Street, from Fortieth Street to Westfield Boulevard.

- (d) Meridian Street, from Sixteenth Street to Westfield Boulevard.
- (e) Meridian Street, and/or Pennsylvania Street, (U. S. Road 31), from 61st Street to 64th Street.
- (f) Union Street, from Merrill Street to Adler Street.
- (g) Central Avenue, north from Thirty-eighth Street to the city limits.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 76, 1935

AN ORDINANCE amending sub-section (e) of Section B-455 of General Ordinance No. 121, 1925, as amended by General Ordinance No. 11, 1931, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That sub-section (e) of Section B-455 of General Ordinance 121, 1925, as amended by General Ordinance No. 11, 1931, be and the same is hereby amended to read as follows:

Section B-455.

(e) Signs projecting from the building wall may be extended to within 2 feet 6 inches of the curb line, but in no case shall such sign extend more than 7 feet from or beyond the face of the building or property line and no projecting sign shall be at its lowest point less than nine feet above the sidewalk level.

EXCEPTION: On streets having sidewalks of 5 feet or less in width projecting signs may be erected attached to a building or structure and permitted to extend to an imaginary line projecting perpendicularly from the curb, provided that the lowest point of said sign is in no case less than 14 feet above the sidewalk level.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and due publication as by law required.

AN ORDINANCE amending General Ordinance No. 114, 1922, commonly known as the Zoning Ordinance, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U5 or second industrial district, the A3 or 2400 square feet area district, and the H1 or 50 feet height district, be and the same are hereby amended, supplemented and changed so as to include the following described territory:

Beginning at a point, said point being the intersection of the center line of Ralston Avenue with the center line of Twenty-second Street, and running north on and along the center line of Ralston Avenue to its intersection with the center line of Twenty-third Street; thence east on and along the center line of Twenty-third Street to its intersection with the center line of Baltimore Avenue; thence south on and along the center line of Baltimore Avenue to its intersection with the center line of Hillside Avenue; thence southwestwardly on and along the center line of Hillside Avenue to its intersection with the center line of Twenty-second Street; thence westwardly on and along the center line of Twenty-second Street to the point or place of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.
