Dear Sir:

I am enclosing herewith fourteen copies of General Ordinance No. 74, 1936, entitled:

AN ORDINANCE concerning the salaries, wages and compensation of officers and members of the Indianapolis Police Department and members of the Indianapolis Fire Department, Indianapolis, Indiana, supplementing, suspending and repealing any and all general, special and appropriation ordinances heretofore enacted and in conflict herewith; also of any ordinance of the City of Indianapolis, Indiana, or any executive order heretofore made by any Board, Commission, Department or governing body of any department or official of said City; and fixing a time when the same shall take effect.

Due to the increase in the price of foodstuffs, rent and practically all of the necessities of life, I feel that the City of Indianapolis should restore to the Indianapolis Police Department and the Indianapolis Fire Department not only the full amount of the pay which was taken from them but that the salaries should be increased in comparison with the cost of living.

The Police and Firemen of this city have been first to extend a helping hand where charity and relief were needed, in many cases long before charitable organizations had the opportunity to give relief. The average Police Officer and Fireman has been obliged to give at least ten per cent of his salary in donations to various relief matters including various benefits and charitable enterprises.

I think the City of Indianapolis should appreciate the good work that these men are doing, not only in promoting public safety but in reducing fire losses to a minimum resulting in lower insurance rates. At this time when many large corporations and business men in general are endeavoring to increase the salaries of their employees I feel

that our Municipal Government should not be backward or stringent in rewarding the men who have served Indianapolis wholeheartedly in promoting its safety and general welfare.

I again submit this Ordinance asking for a reasonable and substantial increase in the Police and Firemen's salaries to cope with the higher cost of living and also to restore to them cuts that were taken in the past.

Section 1. That the offer of the United States of America to the City of Indianapolis to aid by way of grant in financing the construction of a new service building unit for the Indianapolis City Hospital, a copy of which offer reads as follows:

Section 3. That the city clerk of the City of Indianapolis be and he is hereby authorized and directed forthwith to send to the Federal Emergency Administration of Public Works three (3) certified copies of this ordinance and three (3) certified copies of the Proceedings of the Common Council of the City of Indianapolis in connection with the passage of this ordinance, and such further documents or proofs in connection with the acceptance of said offer as may be requested by the Federal Emergency Administration of Public Works.

Section 4. It is hereby covenanted that work on the project described in the offer will be commenced as early as possible, but in no event later than January 11, 1937; that the work will be planned so that it will reach a substantial peak before April 11, 1937; and that the project will be completed by January 11, 1938.

Section 5. That the Board of Health of the City of Indianapolis be and it is hereby authorized, for and on behalf of said City of Indianapolis, to enter into any and all contracts and to do all other things which may be necessary or desirable in the opinion of said board to fully carry out and comply with all the terms and conditions of said Offer and Grant from the United States of America.

Section 6. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.
