Council met: Present Mr. N.B. Palmer President; Messrs Lockerbie, Sullivan, McCluer, Seibert Norwood & Rooker Councilmen:

Ordered that the Marshal have the Bridges over Pogues run on Delaware; Illinois and Meredian Streets repaired and also the street south of Meredian Street bridge filled and he also have a gravel walk made across Delaware Street north of Washington Street.

Ordered That the Town Surveyor; (under the direction of the Councilman of the Second ward) make such examinations and surveys as may be necessary to ascertain the practicability of draining Massachusetts Avenue and Delaware Street and also of filling up said Streets.

Mr. Sullivan from the Committee On Cisterns reported that the Committee had performed the duty assigned it.

Whereupon On Motion of Mr. McCluer

Resolved That the Committee On Cisterns be authorized to contract with some person or persons for the construction of two Cisterns each to hold 300 barrels of water and that said Committee select the location for said Cisterns.

On Motion of Mr. Seibert

Resolved that a committee be appointed to examine and report to the Council what improvements are necessary to prevent the water from running round the South end of the Bridge over Pogues run on Meredian Street.

Messrs Seibert McCluer & Horwood were appointed said Com.

On Motion of Mr. Sullivan

Resolved That a committee be appointed, who in conjunction with the Treasurer shall settle all accounts with the Collector.

Messrs Sullivan & Seibert were appointed said Committee.

Ordered That the Treasurer be directed to submit his annual report to the Council on the 1st. inst.

An Ordinance entitle "An Ordinanace To provide for the election of a President and Six Councilmen in the town of Indianapolis" was read, amended, passed and ordered to be published.

Whereupon the Council adjourned to meet on the twentyfirst inst; at two oclock.
