Ordered That the said Petitioners have leave to withdraw their said petition.

The President laid before the Council an ordinance entitled "An Ordinance to prevent Dogs from running at large in the town of Indianapolis and for other purposes." which was read, amended, and passed, and secretary ordered to have the same published.

Ordered That the Salary of the Secretary for the present year be fixed at one hundred and twenty five dollars.

Ordered That the Salary of the Messenger to the fire department for the present year be fixed at fifty dollars.

Ordered That the Salary of the Market Master for the East & West Markets for the present year be fixed at one hundred dollars.

Ordered That the Secretary issue orders to the officers of town for their first quarters Salary.
