Resolved by the Common Council of the town of Indianapolis That we do solemnly protest against the occupancy of any Street or alley by the Madison and Indianapolis Rail Road Company, for the purposes of a depot for the Madison and Indianapolis Rail Road, within the Corporate limits of said town -- Mr. Goldsberry moved to amend said resolution by providing any street may be used as a depot for said road provided the persons owning the property on each side of said street would give their assent to the same, and called for the yeas, and noes on the amendment. Those voting in the affirmative were Messrs. Goldsberry and Montague. Negative Messrs. Griffith, Loudon and Rooker. The Resolution was then adopted.

Ordered That the Secretary make out an abstract of the receipt and expenditures of Com. Council for the Current year 1844 from the Treasurers Annual Report and other papers in his office and furnish a copy to the Indiana State Journal and Sentinel for Publication.

Mr. Griffith from the Committee to whom was refered the acct. of S. V. B. Noel for \$30. for Printing for the year 1844, reported the same back and recommended it allowance Whereupon the sum of \$30. was allowed as per acct.

D. 1845, upon his presenting the Treasurer's receipt for fifty dollars, and otherwise Complying with the Ordinances on that subject.

On Motion of Mr. Goldsberry

Ordered That the fine assessed by the President against W. Y. Wiley, and William Biddle & John E. Foudray for violation of the ordinance regulating the appointment and duties of town auctioneers, be remitted upon their paying all costs of suit within thirty days from this date.
