

Council Chamber
Indianapolis March 7th 1846.

The Council convened in regular meeting, Present the President and all the Councilmen.

Mr. Griffith presented the Treasurers report for the Month of February last past, which was read and received. Also The Treasurers annual report, showing receipts from various sources since the 1st of April last past to the Amount of \$2195.11 $\frac{1}{4}$ and expenditures to the Amount of \$2148.04 - Bal. in Treasury March 7th/46 - \$47.07 $\frac{1}{2}$, which report was in like manner read and received.

The President laid before the Council the report of the Weighmaster for the Month of February last past, which was read and received.

Mr. Griffith, presented the petition of Geo. Norwood and James Vanblaricum, praying a Suspension of the provisions of a Notice to cause all streets to be opened in their application to them until they shall have harvested a crop now sown upon streets enclosed, which petition is granted.

Mr. J. M. W. Langsdale, makes application for License to vend spirituous and strong liquors by retail in the town of Indianapolis, for one year from the 7th day of March A. D. 1846. And upon the question of granting such license, the Ayes and Noes being demanded - Those who voted in the affirmative were Messrs. Montague, Nowland, Louden & Griffith 4. Those who voted in the Negative were Messrs. Goldsberry & Vanblaricum 2. It is therefore ordered that the Secretary issue such license to Mr. Langsdale upon his compliance with the provisions of the Ordinance regulating such licenses.

Mr. John Bishop makes application for license to vend Spirituous and Strong liquors by retail in the town of Indianapolis for one year from the 11th day of December A. D. 1845.

Ordered - That the Secretary issue such license to the applicant upon the presentation of the Treasurers receipt to him for the amount of such license.

Mr. Brown, now petitions the Council to permit him to keep a portion of certain streets upon which he has wheat sown, enclosed, until he shall have harvested the crop, which prayer is not granted. It is however, Ordered, that Mr. Brown have permission to keep said streets enclosed until the next regular meeting of the Council.

On Motion of Mr. Goldsberry

Resolved, That the Market Master of the East Market, cause the stall now occupied by Mr. Foltz to be suitably repaired and make report to the Council at the next regular meeting of the cost of such repair.

The a/c of Frederick Voight for \$0.75 for labor in 4th ward, was laid upon the table.

Resolved, That Jacob Miller Market Master of the West Market be and he is hereby appointed Market Master of the East Market to fill the vacancy occasioned by the decease of Mr. Wormagen, late Market Master of said East Market.

On Motion of Mr. Goldsberry

Resolved, That a Committee be appointed to make settlement with Henry Ohr Collector of the Revenue of the town of Indianapolis to make report of the result of such settlement at the next meeting of the Council.

Whereupon the President appointed Messrs. Griffith, Goldsberry & the Secretary and Treasurer said Committee.

Ordered. That the Secretary issue Orders to the members of the Council for their last $\frac{1}{2}$ years salary, And also to the Officers of the Corporation for their 4th quarters salary.
