

Council Chamber  
Thursday June 8th 1854

The Council met at two O'clock P M. Present the President and all the Councilmen except Mr. Colley. The minutes of the preceeding meeting were approved.

The committee on accounts reported in favor of allowing the accounts of Hiram Lewis Frederick Fealing and H. S. Kelling.

On motion the following accounts were allowed

The Committee to whom was referred the bids and proposals for building an Engine House for the Invincible Fire Company reported that Messrs Hefferman, Dunning, and Parker made the Lowest bid for said house. The amount of said proposal being \$910 for building according to specifications, and \$40 for the first Section of the Cupola.

Mr. Karnes moved

That the contract for building said Engine House be awarded to Messrs Hefferman, Dunning and Parker. Which motion prevailed.

Mr. Seibert moved

That the Civil Engineer be instructed to put a cellar under the Engine house for the Invincible Fire Company. Which motion prevailed.

Mr. Nelson moved

That the Market Master be authorized to put up a rack at the West Market House. Which motion prevailed.

Mr. Avery moved

That the Market Master be authorized to put up a rack at the East Market House. Which motion prevailed.

Mr. Pitts moved

That the City Treasurer be authorized to pay a note due from the City to Mr. Campbell. Which motion prevailed.



Mr. Maguire moved

That the Assistant Civil Engineer be allowed three hundred dollars per annum for his services. Which motion prevailed.

Mr Maguire presented the following ordinance

An Ordinance to repeal an Ordinance entitled "An Ordinance relative to Pumps on Washington Street" ordained 22nd August 1853.

Sec 1 Be it ordained by the Common Council of the City of Indianapolis, That the Ordinance passed the 22nd day of August 1853 entitled "An Ordinance relative to Pumps on Washington Street" be and the same is hereby repealed.

In the negative - None.

Mr. Dunlap moved:

That the Ordinance in relation to Theatres Shows etc be referred back to the Committee on the Judiciary. Which motion prevailed.

Mr. Karns moved

That the Ordinance in relation to the licenseing of omnibuses hacks etc be referred back to the Committee on the Judiciary. Which motion prevailed.

Mr. Dunlap moved

That the Ordinance and the amending Ordinance thereof in relation to the erection of wooden buildings on Washington Street be referred back to the Committee on the Judiciary. Which motion prevailed.

On motion the Council adjourned to meet on Friday June 9th 1854 at Seven O'clock P M.
