Gentlemen:—Your Committee on Contracts, together with the Chief Fire Eng neer and City Civil Engineer, to whom was referred the bids for the construction of the Prospect street Engine House, have examined the same, and find them to las follows, viz:

All of the bids exceed the amount of the unexpended balance of the appropriaion intended to cover all expenses connected with the purchase of the lot, prepaation of the plans, and cost of building.

In view of these facts, and the additional fact that the Architect was positively nstructed by the City Civil Engineer and Chief Fire Engineer to make plans for building to cost within \$4,300.00, and as shown by the bids the lowest one is \$4,749.00, we do not feel warranted in recommending the awarding of said contract, in the present plans, but would suggest that the Council recede from the limit blaced upon the expense of the building, or else authorize the City Civil Engineer and Chief Fire Engineer to make such alterations as will bring the cost of said suilding within the appropriation. This, we think, would not be advisable, as it is to be a permanent building, and should be well built. And further, we think we have a very low bid, as two other houses, just like this one, were built at an expense of near \$6,000.00. We therefore think it would be more economical to increase the appropriation \$500.00, than to have an inferior building erected. The original appropriation was \$5,000.00, which was to cover all expenses, including purchase of the analysis of the building. The amount expended to date is as follows: Lot, \$700.00; plans and specifications, \$75.00.

Also, y striking out the word "Square," and inserting in lieu thereof the word "Space." Iso, by adding to the end thereof the following: "Provided, further, that the ain building across the west end of said Market Space, shall be built first; and uring its building, the balance of the Market Space shall not be incumbered with uilding material, but the old Market House and Space shall be reserved for the ablic market until such time as the market space under the man building is ready be used for market purposes. The Architect shall draw his plans to comply ith this proviso."

Amend Section four by striking out the words from "shall," to and including the cords "building committee," and inserting in lieu thereof the following words: Shall by like resolution select two members of the Common Council, one Demorat and one Republican, and also one member of the Board of Aldermen, who hall be a Democrat, and such persons, with the Mayor and President of the Board of Aldermen, shall constitute a building committee."

To amend: That all in Section IX "nine," after the word "annulled," be stricken ut.

The receipts therefrom are not included in the foregoing statement of receipts. The amount received from this source on hand January 1st, 1885, is \$30,845.91.

Also, balance on hand from liquor licenses, &c., not included in the foregoing statement of receipts, set apart under ordinance as additional City Hall Fund, January 1st, 1885, \$45,749.94.

The receipts from the last named source are covered into said City Hall Fund in August of each year, so that said statement only includes receipts to said fund to August, 1884.
