Gentlemen:—At your last meeting you directed me to report a plan to abate the nuisance, in the shape of a pond, on the Michigan Road, between Sixth and Seventh streets. I have examined into the matter, and recommend that for immediate relief, the road between Sixth and Seventh streets be filled to a depth of four (4) feet, by the Street Commissioner. But to render proper and permanent relief, I would recommend the construction of a four (4) foot sewer on the line of Seventh street, from the Michigan Road to Fall Creek; which in time could be extended east as far as Meridian street, and thereby relieve the accumulation of water at the corner of Seventh street.

Gentlemen:—The Board of Public Improvements, to whom sundry papers were referred, would report thereon as follows:

1st. Is a petition for the construction of a stone wall in Pogue's Run, between Catharine and McCarty streets.

To raise the sidewalks and fix the gutters of south East street, from a point 250 feet south of Washington street to a point 750 feet south of Washington street, to conform to the grade recently made in constructing the bridge over Pogue's Run. The work to be done according to stakes set by the City Civil Engineer.

Recommend the work be done under ordinance, providing the property owners petition for the same.

Gentlemen:—The undersigned, owners of real estate fronting on Delaware, Davis and High streets, between Bicking and Coburn streets, respectfully remonstrate against the passage of an ordinance providing for the grading and bowldering of the first alley south of Bicking street, from Delaware street to High street.

Thos. F. Quill, 150 feet; J. T. Richey, 150 feet; Wm. Raesner, 150 feet; Elizabeth K. Davis, 150 feet; H. Glathfelder, 150 feet; F. Rand, Receiver Indiana Banking Company, 150 feet.

That Murphy, Hibben & Co. be granted the privilege of constructing a tunnel between their buildings, across Sciota street, near the corner of Georgia street; all work to be done under the supervision of the City Civil Engineer, at their own expense.

Councilman Reinecke offered the following resolution; which was referred to the Committee on Water:

Resolved, That the Indianapolis Water Company be, and is hereby requested to extend its lines of water-mains on Shelby street from the south end of Virginia avenue to Willow street; and to locate one hydrant for every five bundred (500) feet of pipes so extended; all to be done under the direction of the Chief Fire Engineer. And the City Clerk is hereby directed to notify said Indianapolis Water Company of this action.

Councilman Reynolds offered the following resolution; which was referred to the Committee on Railroads:

WHEREAS, It is deemed expedient that a line of Street Railway should be constructed along Clifford avenue, from its intersection with Massachusetts avenue to Keystone avenue. Therefore,

Resolved, That the Citizens' Street Railway Company of Indianapolis be ordered and directed to construct and operate a line of street railway extending from the intersection of Massachusetts and Clifford avenues, along Clifford avenue to Keystone avenue; and that the City Clerk be and is hereby instructed to serve a copy of this resolution, duly attested by the Mayor, and City Clerk, upon the President; or, in his absence, upon any Director of said company.

Councilman Smither offered the following remonstrance; which was ordered filed:

To the Mayor, Common Council and Board of Aldermen of the City of Indianapolis:

Your petitioners humbly, but with the most extreme earnestness and anxiety, beg that your honorable bodies will not order the improvement of Reid (or State) street, between the C, I., St. L. & C. R. R. tracks and Woodlawn street; sach improvement is not sought or desired by a majority of owners, either in number of persons or in feet of ground owned. Many of the lots are situated in their length sidewise to Reid street, and owned by very poor people, deeply depressed with the burden of a livelyhood at this time of great depression; others are owned by persons out of employment, vainly seeking for work, and paying even their taxes with the greatest difficulty. All or most of the ground on the east side of the street is entirely vacant land, and so cut up with brickyard holes of twenty years ago, and low ground at best, that it is much of the time under water, and thousands of dollars would be require make it at all marketable, an outlay that would be suicidal even if possible in these hard times. Most of the ground on the east side is owned by a widow, in trust for herself and children, who, while certain outstanding legal interests and disputes are unsettled, cannot possibly, without great sacrifice, bear this extreme burden at this time, if indeed it can be borne at all. In fact, the chief and almost only owners seaking this improvement, are one or two men owning only one or two lots fronting on the street, as your petitioners are informed, aside from a non-resident ownership, who, under the rules guiding your honorable bodies, do not usually have any voice either for or against street improvements. In short, the improvement of the street is unnecessary, unwise, and keenly cruel at this time, and if prosecuted, will simply amount to a surrender of, and legalized confiscation of, the abutting property on the east side, as well as lots belonging to a needy blacksmith, and others, on the west side—a confiscation unintended by your honorable bodies, but no less actual, as the result will show. Will not your honorable bodies refuse to make possible such infinite unnecessary hardship and sacrifice?

And your petitioners will ever pray, etc.
