

PROCEEDINGS OF COMMON COUNCIL.

REGULAR SESSION—OCTOBER 17, 1887.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, October 17th, A. D. 1887, at 7:30 o'clock, in regular session.

PRESENT—Hon. Caleb S. Denny, Mayor, and *ex officio* President of the Common Council in the Chair, and 19 members, viz: Councilmen Burns, Coy, Cummings, Dell, Dunn, Haugh, Mack, Markey, McClelland, McGroarty, Newland, Pearson, Reinecke, Smith, Smither, Stuckmeyer, Swain, Thalman, and Waterman.

ABSENT, 6—viz: Councilmen Benjamin, Edenharter, Herig, Howes, Reynolds, and Rooker.

The Proceedings of the Common Council for the regular session held October 3d, 1887, having been printed and placed on the desks of the Councilmen, said Journals were approved as published.

OPENING AND REFERRING SEALED PROPOSALS FOR PUBLIC IMPROVEMENTS.

Sealed proposals for the following street improvement was opened, read, and referred to the Committee on Contracts:

(S. O. 69, 1887)—For the re-grading and paving with Medina (New York) sand stone the roadway, and curbing with stone the gutters of Washington street, from the east line of Mississippi street to the west line of Alabama street, and requiring the Citizens' Street Railway Company to pay a portion thereof, as provided for in General Ordinance No. 4, 1884.

The City Attorney submitted the following report; which was received :

To the Mayor, Common Council and Board of Aldermen :

Gentlemen:—Since the last meeting of the Council, the damage suit of Samuel W. Patterson vs. The City, has been tried. This was an action for \$7,500 damages alleged to have been caused by the forfeiting of a contract with and by the city, for the improvement of Indiana avenue. The Board of Aldermen at its next regular meeting after awarding the contract, reconsidered said action, and then refused to award it. Judge Howe holds that the rules of the Board by which said action was reconsidered, are binding on every one who deals with the city. The plaintiffs dismissed their case.

Since this action was begun, a provision has been inserted in all advertisements for street improvements, to the effect that no contract is complete until a formal written contract shall have been entered into and approved by the city. This will save all question in the future.

The Committee on Streets and Alleys and City Attorney, through Councilman Dunn, submitted the following report; which was ordered filed with the ordinance:

To the Mayor and Common Council:

Gentlemen:—Your Committee on Streets and Alleys, together with the City Attorney, to whom was referred G. O. 33, 1887, granting the Indianapolis Writing Telegraph Company the right to use the streets and alleys of this city, report that having considered said ordinance, we recommend that the following amendment thereto be adopted, to wit:

1st. Amend Section one so as to read as follows:

"SECTION 1. *Be it ordained by the Common Council and Board of Aldermen of the City of Indianapolis,* That the right is hereby granted to the Indianapolis Writing Telegraph Company to erect and maintain writing telegraph lines, and to occupy the streets and alleys with the necessary poles and wires for the proper transaction of writing telegraph business."

2d. Amend Section two by adding to the end thereof the following proviso:

"*Provided,* That said company shall be liable for all damages occasioned by its employes in erecting and repairing its poles and lines, and for all damages occasioned by its poles and wires being placed on the streets and alleys: *And provided,*

further, That this ordinance is passed upon the express condition and consideration that said company is to furnish the city, free of cost or charge, for the purpose of connecting its several offices, engine and reel houses by telegraph, the use of twenty-five writing telegraph instruments, with all necessary appliances for connecting and operating the same.

3d. Add the following Section, numbered "Section 4," to said ordinance:

"SECTION 4. The city reserves the right to repeal this ordinance at any time."

4th. Re-number Section 4 in the ordinance as Section 5.

And when said ordinance shall have been so amended, we recommend that the same do pass.

INTRODUCTION OF GENERAL AND SPECIAL ORDINANCES.

Under this order of business the following entitled ordinances were introduced, and severally read the first time:

By Councilman McGroarty, which was referred to the Committee on Public Light:

S. O. 142, 1887—An ordinance to provide for the erection of lamp-posts, lamps and fixtures (complete to burn gas, except the service pipes), on Missouri street, between South and Merrill streets.

By Councilman Reinecke:

S. O. 142, 1887—An ordinance to provide for grading, bowldering and curbing the gutters of Beaty street, from McCarty street to Buchanan street.

S. O. 144, 1887—An ordinance to provide for re-grading and graveling Merrill street and sidewalks, from Virginia avenue to East street.

S. O. 145, 1887—An ordinance to provide for grading and graveling the first alley north of Buchanan street, from Sullivan street to the first alley west of Virginia avenue.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

Councilman Burns offered the following motion; which was adopted:

That the Street Commissioner be directed to clean the gutters and fill with gravel the chuck-holes on Bloomington street, from Washington street to Beacon street.

Councilman Burns offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be directed to grade the north gutter of Washington street, from Bloomington street to Belmont avenue.

Councilman Coy offered the following motion; which was referred to the Rental Committee, with power to act:

That the Metropolitan Police Force be granted the use of Tomlinson Hall Wednesday night, October 19th, 1887, free of charge.

Councilman Cummings offered the following motion; which was adopted:

That the Street Commissioner be directed to haul the dirt that accumulates about the market, after it has been scraped up in heaps by the Market Master, at least every other day.

Councilman Haugh offered the following motions; which were adopted:

That the City Civil Engineer be, and is hereby, instructed to remove one of the vapor lamps on Michigan street, between Liberty and Noble streets, and place the same on Leon street, at the first alley north of Michigan street.

That the City Civil Engineer be instructed to move the lamp on Vermont street, between Alabama and New Jersey streets, to the corner of Vermont and Budd streets.

Councilman Mack offered the following motion; which was referred to the Committee on Water:

That John Stroble be permitted to place a drinking fountain in front of his property on the corner of Madison avenue and Phipps street, at his own expense, and that the city furnish water for the same.

Councilman Mack offered the following motion; which was referred to the Board of Public Improvements, with power to act:

That the Street Commissioner be directed to fill up Locust street, between No. 22 School House and Hanway street, where needed.

Councilman Markey offered the following motion:

That the City Civil Engineer be instructed to order stone crossings across Delaware street at the west end of Bicking street, and East street at the east end of Bicking street.

Councilman Cummings moved to refer the motion to the Board of Public Improvements.

Councilman Haugh moved to table the motion offered by Councilman Cummings.

Which was adopted, by the following vote:

AYES, 12—viz: Councilmen Burns, Cummings, Dell, Haugh, Mack, Markey, Newland, Rienecke, Smither, Stuckmeyer, Swain, and Waterman.

NAYS, 5—viz: Councilmen Dunn, McClelland, McGroarty, Smith, and Thalman.

Councilman Cummings filed notice that he would, at the next meeting, move to reconsider the above vote.

The original motion offered by Councilman Markey, was then adopted.

Councilman Mack moved to reconsider the adoption of the motion.

Which was, on motion by Councilman Stuckmeyer, laid on the table.

Councilman Markey offered the following motion; which was referred to the Committee on Public Light:

That the Sun Vapor Light Company be instructed to place one sun vapor light on Madison avenue, between Nebraska street and Lincoln Lane.

Councilman McClelland offered the following motion; which was referred to the Board of Public Improvements and City Civil Engineer:

That the Street Commissioner be instructed to repair the bridge on Archer street over Pogue's Run.

Councilman Newland offered the following motions; which were adopted:

That the Street Commissioner be, and is hereby, ordered to clean the gutters on Spann avenue, from Dillon street to Spruce street.

That the Street Commissioner be, and is hereby, ordered to clean the gutters on Olive street, from Prospect street to Pleasant Run.

Councilman Smith offered the following motions; which were adopted:

That Geo. Mannfield be granted the privilege of laying a brick sidewalk along his property on Walnut street, and the City Civil Engineer set the stakes for the same.

That the City Civil Engineer correct the numbers on the west side of New Jersey street, between Walnut and Gregg streets.

Councilman Stuckmeyer offered the following motions; which were adopted:

That R. Wigington and others, be granted permission to curb and bowlder the gutter in front of their property on Elm and Pine streets, at their own expense, and that the City Civil Engineer set the grade stakes.

That the Street Commissioner be, and is hereby, directed to lay a double stone crossing at the intersection of Hoyt avenue across Dillon street.

Councilman Stuckmeyer offered the following motion; which was referred to the Board of Public Improvements:

That the Street Commissioner be, and is hereby, directed to lay a double stone crossing at the intersection of School street across Huron street.

Councilman Swain offered the following motion; which was adopted:

That the Indianapolis Water Company be, and is hereby, ordered to remove the water plug near the corner of the first alley south of Georgia street, east side of Meridian street, to the corner of said alley. The same to be done under the direction of the City Civil Engineer.

Councilman Thalman offered the following motion; which was adopted:

That the Committee on Printing of the Common Council be, and they are hereby, authorized to make a contract for preparing an Index for the Proceedings of the Common Council and Board of Aldermen for the year 1887.

Councilman Thalman presented the following petition; which was referred to the City Attorney and Committee on Judiciary:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—In 1875 Plum street was opened from Arch street to the first alley north, and Lot 46, in Young's subdivision of Out-lot 181 was assessed fifty dollars (\$50.00) benefits, which was never collected, and the assessment was illegal; but to clear the title of this cloud on said lot, I will pay ten dollars (\$10.00) in settlement of said claim, and ask that this cloud may be removed from my said lot.

Councilman Waterman offered the following motion; which was adopted:

That Mr. A. B. Gates be permitted to lay a stone crossing across Wabash street in front of 126 of said street; to be done at his own expense, and under the direction of the City Civil Engineer.

PENDING ORDINANCES.

The following entitled ordinance was read the second time:

G. O. 33, 1887—An ordinance granting to the Indianapolis Writing Telegraph Company the right to use the streets and alleys in the City of Indianapolis for the purpose of erecting, maintaining and operating writing telegraph lines.

And the following amendments recommended by the Committee on Streets and Alleys and City Attorney (see pages 708 and 709, *ante*), were adopted:

1st. Amend Section one so as to read as follows:

"SECTION 1. *Be it ordained by the Common Council and Board of Aldermen of the City of Indianapolis,* That the right is hereby granted to the Indianapolis Writing Telegraph Company to erect and maintain writing telegraph lines, and to occupy the streets and alleys with the necessary poles and wires for the proper transaction of writing telegraph business"

2d. Amend Section two by adding to the end thereof the following proviso:

"*Provided,* That said company shall be liable for all damages occasioned by its employes in erecting and repairing its poles and lines, and for all damages occasioned by its poles and wires being placed on the streets and alleys: *And provided, further* That this ordinance is passed upon the express condition and consideration that said company is to furnish the city, free of cost or charge, for the purpose of connecting its several offices, engine and reel houses by telegraph, the use of twenty-five writing telegraph instruments, with all necessary appliances for connecting and operating the same."

3d. Add the following Section, numbered "Section 4," to said ordinance:

"SECTION 4. The city reserves the right to repeal this ordinance at any time."

4th. Re-number Section 4 in the ordinance as Section 5.

The ordinance was then ordered engrossed, read the third time and passed as amended, by the following vote:

The following entitled ordinance was read the second time, and ordered stricken from the files :

G. O. 36, 1887—An ordinance to amend Sections 1, 11, 12 and 14, of an ordinance entitled "An ordinance authorizing corporations, firms, companies or individuals, to lay and maintain pipes in the streets, alleys, avenues, lanes and public grounds in the City of Indianapolis, for the purpose of supplying said city and its inhabitants with natural gas, for heating and illuminating purposes;" ordained and established June 27 1887.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time :

S. O. 163, 1886—An ordinance to provide for grading and paving with brick, the north sidewalk of Woodlawn avenue, from Spruce street to Reid street.

And it was passed by the following vote :

AYES, 18—viz: Councilmen Burns, Cummings, Dell, Dunn, Haugh, Mack, Markey, McClelland, McGroarty, Newland, Pearson, Reinecke, Smith, Smither, Stuckmeyer, Swain, Thalman, and Waterman.

NAYS—None.

The following entitled ordinance was read the second time, ordered engrossed, and read the third time :

S. O. 166, 1886—An ordinance to provide for grading and graveling the first alley east of Meridian street, from Fifth street to the first alley north of Fifth street.

And it was passed by the following vote :
